## "AN EYEBALL...FELL DOWN INTO MY LAP."

"An eyeball...fell down into my lap, and that is gross!" exclaimed **Dr. Uta Landy**, the founder of **Planned Parenthood's Consortium of Abortion Providers (CAPS)**, a speaker at the **National Abortion Federation (NAF)** conference. **The audience laughed.**

A newly released video of the **Center for Medical Progress (CMP)** taken at the National Abortion Federation (NAF) conference, like previous videos, exposes the nature of the abortion industry, and its callousness towards human life, and those whom they claim they "serve."

"...[T]he fetus is a tough little object, and taking it apart, I mean taking it apart, on day one is very difficult," relates **Dr. Susan Robinson**, an abortionist at **Planned Parenthood Mar Monte**, who demonstrates how she uses forceps to pull babies apart during abortions.



"You know, sometimes she'll [fetal parts buyer] tell me she wants a brain, and we'll, you know, leave the calvarium in 'til last, and then try to basically take it, or actually, you know, catch everything, and keep it separate from the rest of the tissue so it doesn't get lost," taught **Dr. Deborah Nucatola**, who described in this video how she beheads babies so their skulls and brains can be sold. In earlier videos, Dr. Nucatola casually discussed various abortion techniques used to better obtain fetal body parts that are of the "quality" necessary to sell.

The Deputy Director of the **ACLU Reproductive Health Freedom Project, Talcott Camp**, exclaimed that, "When the skull is broken, that's really sharp! I get it! I understand why people are talking about getting that skull out, that calvarium."

The video goes on to expose Planned Parenthood officials' willingness to sell what remains of the life they have destroyed. "The truth is that some [clinics] might want to do it [sell fetal tissue]...to increase their revenues. And we can't stop them," submitted **Deb Van Derhei**, **National Director of Planned**

**Parenthood's CAPS.** "I know Planned Parenthood sells a lot of stuff to people," proclaimed **Dr. Paul Blumenthal**, **Medical Director Emeritus with Maryland Planned Parenthood.**

What "stuff" would they be talking about? Baby clothes? Diapers? Or parts of babies?

And let's not call them "baby body parts." They are referred to as "fetal tissue." What is a "fetus"? A fetus is not some special species. This term does not identify what a living organism is. It is simply a stage of development. An unborn baby is not a fetus; he or she is just at an age that we refer to an individual as a fetus, similar to referring to someone as toddler, teenager, young adult, adult, and senior citizen.

But what other "stuff" can we harvest and sell?

**Dr. Ann Schutt-Aine**, with **Planned Parenthood Gulf Coast**, educated the undercover investigator how she avoids violating a partial-birth abortion ban.



A partial-birth abortion is conducted by delivering a live baby, but assuring that its head is not out of the birth canal. Inserting scissors into the base of the baby's skull, its brains can be sucked out, prior to removing the rest of the head. The law banning such a procedure was upheld by the **Supreme Court** in *Gonzales v. Carhart* in 2007. However, other methods of abortion are still legal to destroy an older, unborn child.

"If I'm doing a procedure [a partial-birth abortion], and I'm seeing that I'm in fear that it's about to come to the umbilicus [naval], I might ask for a second set of forceps to hold the body in the cervix," explained Schutt-Aine. "[I'll] pull off a leg, or two, so it's not a PBA [partial-birth abortion]."

"There's a lot of clinics that we work with that, I mean it helps them out significantly," explained an unidentified **StemExpress** employee about this technique to avoid the law against partial-birth abortion.

As exposed in the previous videos, StemExpress is one of the brokers who help Planned Parenthood market baby body parts.

"It's not a matter of how I feel about it [the baby] coming out intact, but I gotta worry about my staff and people's feelings about it coming out looking like a baby," worries **Dr. DeShawn Taylor, previous medical director of Planned Parenthood of Arizona.**

"We have the people who do our paperwork for the fetal death certificates; they email us calling them 'babies.' Baby this, baby that, baby so-and-so, and I'm like, that's creepy!" Dr. Taylor reveals. She continues: "In Arizona, if the fetus comes out with any signs of life, we're supposed to transport it...to the hospital."

In response to the CMP investigator asking if there is "any standard procedure for verifying signs of life," Taylor casually responds: "Well, the thing is, I mean the key is you need to pay attention to who's in the room, right?"

As pointed out by **David Daleiden**, the only difference between the methods of how Planned Parenthood kills unborn children and the abortion techniques used by **Dr. Kermit Gosnell** is that "Gosnell was not so careful as to 'pay attention to who's in the room.'"

### Prior Videos

As summarized by *lifeneews.com*, the previous 12 videos:

- **In the first video:** **Dr. Deborah Nucatola of Planned Parenthood** commented on baby-crushing: "We've been very good at getting heart, lung, liver, because we know that, so I'm not gonna crush that part, I'm gonna basically crush below, I'm gonna crush above, and I'm gonna see if I can get it all intact."
- **In the second video:** **Planned Parenthood's Dr. Mary Gatter** joked, "I want a Lamborghini," as she negotiated the best price for baby parts.
- **In the third video:** **Holly O'Donnell, a former StemExpress employee** who worked inside a Planned Parenthood clinic, detailed first-hand the unspeakable atrocities and how she fainted in horror over handling baby legs.
- **In the fourth video:** **Planned Parenthood's Dr. Savita Ginde** stated, "We don't want to do just a flat-fee (per baby) of like, \$200. A per-item thing works a little better, just because we can see how much we can get out of it." She also laughed while looking at a plate of fetal kidneys that were "good to go."
- **In the fifth video:** **Melissa Farrell of Planned Parenthood-Gulf Coast in Houston** boasted of Planned Parenthood's skill in obtaining "intact fetal cadavers" and how her "research" department "contributes so much to the bottom line of our organization here, you know we're one of the largest affiliates, our Research Department is the largest in the United States."
- **In the sixth video:** **Holly O'Donnell** described technicians taking fetal parts without patient consent: "There were times when they would just take what they wanted. And these mothers don't know. And there's no way they would know."
- **In the seventh and perhaps most disturbing video:** **Holly O'Donnell** described the harvesting, or "procurement," of organs from a nearly intact late-term fetus aborted at Planned Parenthood Mar Monte's Alameda clinic in San Jose, CA. "You want to see something kind of cool," O'Donnell says her supervisor asked her. "And she just taps the heart, and it starts beating. And I'm sitting here and I'm looking at this fetus, and its heart is beating, and I don't know what to think."
- **In the eighth video:** **StemExpress CEO Cate Dyer** admits Planned Parenthood sells "a lot of" fully intact aborted babies.
- **In the ninth video:** catches a **Planned Parenthood medical director** discussing how the abortion company sells fully intact aborted babies - including one who "just fell out" of the womb.
- **In the tenth video:** catches the nation's biggest abortion business selling specific body parts - including the heart, eyes, and "gonads" of unborn babies. The video also shows the shocking ways in which **Planned Parenthood** officials admit that they are breaking federal law by selling aborted baby body parts for profit.
- **The 11th video:** catches a **Texas Planned Parenthood abortionist** planning to sell the intact heads of aborted babies for research. **Amna Dermish** is caught on tape describing an illegal partial-birth abortion procedure to terminate living late-term unborn babies which she hopes will yield intact fetal heads for brain harvesting.
- **The 12th video:** shows new footage of **Jennifer Russo, medical director at Planned Parenthood in Orange County, California**, describing to

undercover investigators how her abortion business tries to harvest intact aborted babies' bodies for a local for-profit biotech company and changes the abortion procedure to do so.

### ***The Persecution Continues***

On March 28, 2017, **California Attorney General Xavier Becerra** announced that 15 felony charges were filed against **David Daleiden and Sandra Merritt of CMP**.

"The public knows the real criminals are Planned Parenthood and their business partners like StemExpress and DV Biologics - currently being prosecuted in Orange County - who have harvested and sold aborted baby body parts for profit for years in direct violation of state and federal law. I look forward to showing the entire world what is on our yet-unreleased videotapes of Planned Parenthood's criminal baby body parts enterprise," responded David Daleiden.

It is noted that David Daleiden also had criminal charges brought against him in Houston, Texas, and as a hearing date approached, the prosecutor (a longtime public supporter of Planned Parenthood) was smart enough to abandon the fake criminal charges prior to being made a fool of in a court of law.

Only last January, a Congressional panel of the U.S. House of Representatives recommended numerous criminal referrals against Planned Parenthood. California's Orange County District Attorney is pursuing action against two companies for their involvement in the marketing of fetal body parts. One of those companies, **StemExpress**, was held in contempt by Congress last year for its refusal to comply with this investigation, reports *The Wanderer*, a national Catholic newspaper.

### ***Privacy***

"The right to privacy is a cornerstone of California's constitution, and a right that is foundational in a free democratic society," explained **Attorney General Xavier Becerra**. "We will not tolerate the criminal recording of confidential conversations."

Where in California's constitution is there a right to privacy? Where is it stated in the laws of California that it is a foundational right in a free democratic society? When are criminal charges based on someone's political rhetoric? When is it a crime to record a conversation when no one at the time claimed or thought that it was confidential?

Were any of the videos of confidential conversations? In fact, most of the conversations were anything but private. One of the first videos took place at a restaurant at which Dr. Nucatola was eating a salad and drinking wine, while she discussed "crush above" and "crush below" procedures to obtain valuable body organs, so that she could kill the baby without ruining

the baby's commercial value. Waiters and other patrons were well within earshot. In the latest video, the discussions were either public or made on the convention floor where one could view lots of people standing near and walking by while the conversation was being videotaped.

### ***Judge Strong Supporter of Abortion***

It has been recently disclosed that **U.S. District Judge William Orrick**, who had issued a gag order preventing the release of the videos, has served on the board of directors of an organization that houses a Planned Parenthood clinic.

As reported by *lifesitenews.com*, Judge Orrick is a former board member of **Good Samaritan Family Resource Center (GSFRC)**, having served as its secretary in 2001 when it entered a "key partnership" with **Planned Parenthood of San Francisco**. Attorneys for CMP filed a motion seeking the removal of Judge Orrick from this case.

"At no time did Judge Orrick disclose to Defendants that he sat on the board of an organization that had as a 'key partner' an organization Defendants alleged, both in public statements and as part of their defense, was involved in violations of state and federal law," CMP's motion continues. "Judge Orrick did not disclose his close and longstanding relationship with an organization that houses a facility and hosts Planned Parenthood staff, whom NAF [National Abortion Federation] claims are in physical danger from 'anti-abortion extremists' indicted by Defendants."

As *The Federalist's Mollie Hemingway* uncovered, "He also donated more than \$5,000 to GSFRC." "He raised at least \$200,000 for Obama and donated \$38,800 to committees supporting him, according to Public Citizen," reported Hemingway.



## KENTUCKY COURT OF APPEALS GETS IT RIGHT

During the fiscal year, July 2015 through June 2016, Planned Parenthood received, according to their own report, \$554.6 million in taxpayer funds, which was the record high for the abortion conglomerate. Although Planned Parenthood reports fewer customers, it does

In May, the **Kentucky Court of Appeals** upheld the right of a t-shirt printer to decline to print t-shirts promoting the Lexington Pride Festival 2012, for the **Gay and Lesbian Services Organization (GLSO)**.

The **Lexington Fayette Urban County Human Rights Commission** found **Hands On Originals (HOO)** violated the Fairness Ordinance of Lexington-Urban County Government.

However, **Judge James D. Ishmael, Jr., of the Fayette Circuit Court**, reversed the Commission, finding that HOO did not violate the Fairness Ordinance; and even if HOO had violated it, the Ordinance was unconstitutional as it was applied in this case.

By a 2-1 decision, the Kentucky Court of Appeals upheld the Circuit Court. The Opinion written by **Chief Judge Joy Kramer** of Covington, Kentucky, noted that "Nothing of record demonstrates HOO, through Adamson [the owner of HOO], refused any individual the full and equal enjoyment of the goods, services, facilities, privileges, advantages, and accommodations it offered to everyone else *because* the individual in question had a specific sexual orientation or gender identity." (Emphasis by Court).



"[T]he t-shirts the GLSO sought to order from HOO are an example of its support and advocacy of *others*... the GLSO's desire to sell these shirts to everyone clearly imparted a *message*."

"...[T]he right of free speech does not guarantee to any person the right to use someone else's property, even property owned by the government and dedicated to other purposes, as a stage to express ideas."

The Court did not address the conclusion arrived at by Judge Ishmael that this Fairness Ordinance under the circumstances of this case was unconstitutional.



Concurring in the results only, **Judge Debra Hembree Lambert** of Somerset, Kentucky, found: "HOO did not refuse to print the shirts simply because the GLSO representative is a member of a protected class listed in the fairness ordinance. Rather, HOO refused to print the shirts because the HOO owners believe the lifestyle choices promoted by GLSO conflict with their Christian values."

"...[T]he fairness ordinance forces the owner to either join in the requested violation of a sincerely held religious belief, or face a penalty, ...Such coercion violates KRS 446.350. In the face of the protected religious freedoms afforded to HOO under both the Federal and State Religious Freedom Restoration Acts, and *Hobby Lobby*, the fairness ordinance is therefore invalid as applied in this case."

"Americans should always have the freedom to believe, the freedom to express those beliefs, and the freedom to not express ideas that would violate their conscience," said **Alliance Defending Freedom (ADF) Senior Counsel Jim Campbell**, who argued on behalf of Adamson before the appeals court in December.

Campbell said the May 12 decision "is a victory for printers and other creative professionals who serve all people but cannot promote all messages. It is also a victory for all Americans because it reassures us all that, no matter what you believe, the law can't force you to express a message in conflict with your deepest convictions."

"Protecting Blaine's freedom affirms everyone's freedom, no matter the nature of their beliefs or convictions," Campbell said. "The government shouldn't be able to force citizens to create speech that conflicts with their deepest convictions, and the trial court's decision rightly affirmed that."

**Judge Jeff Taylor** of Owensboro dissented.

## ASSISTED SUICIDE: WHO CARES ABOUT CARING ANYMORE?

Last November, the **Council of the District of Columbia** voted 11 to 2 to legalize assisted suicide, joining six other states. Such an action will only encourage the assisted suicide/euthanasia movements throughout the country.

A statute legalizing assisted suicide puts the most vulnerable people at risk. People who are sick, poor, and the elderly will be the target to be pressured

into ending their lives by those who have deemed their lives unworthy to be lived.

In some states, health insurance companies have declined to pay for necessary treatment, while offering to compensate those who assist others in taking someone's life. One would be naïve to think that the costs of caring for someone, which would obviously be more expensive than the expense of assisting someone in suicide, is not a strong motivation.

Assisted suicide no doubt will also lead to changes in the mental attitude of the medical profession. Instead of feeling bound by the *Hippocratic Oath*, to do no harm, the doctor will see his role as not one of healing but one of killing the patient.

Like the assisted suicide law in other states, the D.C. law requires no accountability or transparency. Even though death is intentionally brought about, the law requires that on the death certificate the cause of death be deceptively listed as the underlying illness or disability, which in fact did not cause death. Nowhere else in medicine is this acceptable, as pointed out by **Congressman Brad Wenstrup (R-OH)**.

Rep. Wenstrup, a physician and strong supporter of patients' rights, has been urging Congress to repeal this D.C. statute, stating that it is not a partisan issue, but a human issue.

It should be noted that this law does not require any witnesses, much less a doctor, to be with the patient when a lethal drug is administered.

Assisted suicide is not limited to just those who have terminal illnesses, nor does it require that the patient be even evaluated for mental illness.

So if your mother, who has Alzheimer's, is not in a state that allows for assisted suicide, you can always take a trip to Washington, D.C., to have her "cared for."



*Little Sisters of the Poor*

**Sister Constance Veit, LSP**, the communications director for the **Little Sisters of the Poor**, has expressed her deep concern about assisted suicide. This order of nuns, who although well known in

their own right for caring for the elderly who do not have the financial means to care for themselves, gained national attention when they publicly refused to abide by **President Obama's** HHS Mandate, that they, like all employers, must provide healthcare insurance which pays for contraception, sterilization, and abortion-inducing drugs. The lawsuit they filed is still pending.

Sister Constance noted: "...that [which] most struck me during the Council's one-dimensional discussion was their constant invocation of the concept of absolute personal autonomy and choice, and the manipulative use of emotions to justify 'medical aid in dying,' as this practice is euphemistically called."

Sister goes on to quote **Saint John Paul II**: "Man is no longer able to see himself as 'mysteriously different' from other earthly creatures; he regards himself merely as one more living being, as an organism which, at most, has reached a very high stage of perfection."

"Council members invoked the right over one's body, the right to personal choices and the individual's right to privacy versus the state's right to ensure the safety of D.C. residents," states Sister Constance. "One member went so far as to claim that respecting another's wish to control his or her life and death is an extension of the Hippocratic Oath's injunction to 'do no harm.'

"No one on the Council acknowledged the reality that none of us is ever truly independent throughout life. Each of us belongs to a family and/or community. Our personal decisions are never really ours alone; they always have an impact on others, especially those closest to us. Saint John Paul II spoke of a distorted notion of freedom 'which exalts the isolated individual in an absolute way, and gives no place to solidarity, to openness to others and service of them.' He also wrote that suffering exists in the world in order to unleash love. This love is expressed through the sincere gift of self to those who suffer, creating a cycle of compassion and solidarity.

"But what did you do to relieve your loved one's terrible suffering?" Sister Constance continues. "How did this experience make you a better person? What did you receive from your loved one in their final days that you would not have received if they had checked out early? **An outlook shaped by these questions could make all the difference because it would guide our hearts toward effective, loving responses to the terminally ill, rather than pity, condescension or apathy.**

"In the document entitled *To Live Each Day with Dignity*, the U.S. Bishops issued the following statement: 'When we grow old or sick and we are tempted to lose heart, we should be surrounded by people who ask "How can we help?" We deserve to

grow old in a society that views our cares and needs with a compassion grounded in respect, offering genuine support in our final days. The choices we make together now will decide whether this is the kind of caring society we will leave to future generations. We can help build a world in which love is stronger than death."

**Insurance Companies**

**Dr. Brian Callister**, a physician and professor at the University of Nevada Medical School, relates how some insurance companies have denied his patients life-saving medical treatment coverage, while offering to pay for them to commit suicide.

To support his assertion, he reports two incidents, one where the patient's home state was Oregon and the other California, both of which have legalized drug-prescribed suicide. When he contacted the patients' insurance companies, both refused to cover the patients' treatments, though neither patient was terminally ill but would become so soon if they did not receive the necessary treatment.

According to Dr. Callister, both insurance companies' representatives after denying coverage

couple of drugs, kill you, than it is to provide you life-sustaining therapy. It's as simple as that."

As reported by *lifeneews.com*, **Stephanie Packer**, a young, terminally ill mother of four, stated that California's Medicaid plan refused to pay for her medical treatment, while offering to pay for assisted suicide drugs.

In another case reported by *lifesitenews.com*, two Oregon cancer patients, **Barbara Wagner** and **Randy Stroup**, were offered doctor-prescribed suicide by their state health insurance plans, after being denied coverage for treatment.

In another reported incident, **Kathryn Judson** of Oregon reported that doctors tried to convince her husband, when she was not present, to consider assisted suicide. Fortunately, they switched doctors, and her husband was blessed with five more years.

**CHILD INCEST VICTIM TOLD NOT TO GO TO POLICE**

**Priests for Life** and **Abortion Free New Mexico (AFNM)** recorded on May 5 their conversation with a staff member of the **Southwestern Women's Options** abortuary.

The interviewer, posing as a teenage incest victim 26 weeks along in her pregnancy, was told by one of the members of the abortion staff that no one needs to know of her pregnancy, that a late-term abortion would cost

\$7,500.00, and that the staffer would refer the girl to Medicaid in order to get an abortion for free, reports *lifesitenews.com*.

"The abortion cartel has no interest in protecting these minors and this latest call proves that," states AFNM spokeswoman **Tara Shaver**, who continued: "It is appalling that selling an abortion trumps preventing the continuation of sexual abuse in the life of a young person, but this is the reality of abortion in New Mexico."



"This latest undercover call continues to rip the veil off the abortion industry and show our nation what even most 'pro-choice' people oppose: late-term abortion of healthy babies, paid for by taxpayers, and conducted by an industry which provides cover for sexual predators," states **Fr. Frank Pavone of Priests for Life**.

"Abortion for incest victims sounds compassionate, caring, and heroic; but, in actual practice, it is simply another violent and deceptive tool in the hand of the abuser...abortion does absolutely nothing to protect a young girl from continued abuse and, in fact, aids and abets the abuser in his crime." **Mary Jean Doe** (a pseudonym), a member of **Feminists for Life** and a victim of incest.
