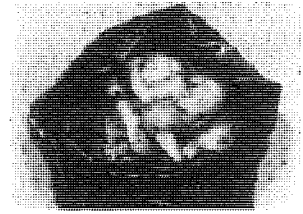

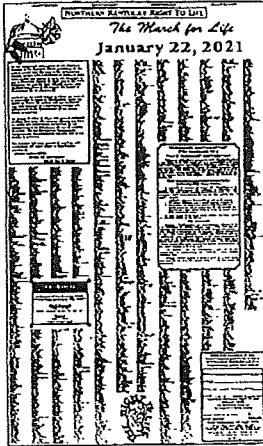

### UNIVERSITY OF LOUISVILLE AND ABORTIONS

On February 26, 2020, **The Family Foundation** staff held a news conference announcing the results of their investigation. Drawn from open records requests and other court documents, they concluded:

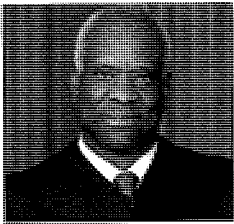
- ▶ The **University of Louisville's School of Medicine** was deeply involved with Kentucky's only operating abortion clinic.
- ▶ The "Ryan Residency program" was initiated by the **Bixby Center for Global Reproductive Health**, whose home is the **University of California in San Francisco**.
- ▶ Medical School OBGYN residents are required to go to the abortion clinic in order to learn the abortion procedures.
- ▶ At least one of the two U of L professors stated about doing abortions: "I consider it part of my - part of my job. That's what the University of Louisville hired me to do. But, you know, EMW is just part of my job responsibilities." (EMW is Louisville's abortion mill.)
- ▶ The clinic does late-term abortions where the living unborn child is simply torn apart, limb from limb in utero. Many of these late-term abortions are after the maturation point when an unborn child can feel pain. At this clinic, the professor testified that there is no anesthesia administered, reports **The Family Foundation** in their May/June 2020 newsletter: *The Kentucky Citizen*.

**The Family Foundation** has requested that **Kentucky Attorney General, Daniel Cameron (R)**, investigate U of L's dealings with **EMW Women's Surgical Center**.

## JUSTICE THOMAS, A VOICE FOR THE TRUTH

In July, the **U.S. Supreme Court** overturned the Louisiana law that required all abortionists to comply

with the state regulation that all freestanding clinics have agreements with local hospitals in case of emergencies. Such a law provided reasonable safeguards for woman having an abortion, like they do for all patients having other types of

Naturally, pro-abortion groups across the country, supported by pro-abortion Democrat politicians and left-leaning news media, claimed a law, claiming that it would interfere with the woman's right to obtain an abortion. How would it stop her from getting a "safe" abortion is a question they ignored.

The Dissenting Opinion of **Justice Clarence Thomas** would benefit any pro-lifer to read. The following are excerpts of one of the great legal minds of our times:

"Today a majority of the Court perpetuates its ill-founded abortion jurisprudence by enjoining a perfectly legitimate state law and doing so without jurisdiction.

**"Roe is grievously wrong for many reasons, but the most fundamental is that its core holding - that the Constitution protects a woman's right to abort her unborn child - finds no support in the text of the Fourteenth Amendment.**

"The idea that the Framers of the Fourteenth Amendment understood the Due Process Clause to protect a right to abortion is farcical. In 1868, when the Fourteenth Amendment was ratified, a majority of the States and numerous Territories had laws on the books that limited (and in many cases prohibited) abortion.

"It would no doubt shock the public at that time to learn that one of the new constitutional Amendments contained hidden within the interstices of its text a right to abortion. The fact that it took this Court over a century to find that right all but proves that it was more than hidden - it simply was not (and is not) there."

## LITTLE SISTERS OF THE POOR PREVAIL

After numerous prayers and sacrifices of the **Little Sisters of the Poor**, their numerous supporters, and their grateful patience brought about a great blessing for our nation. In a 7 to 2 decision, the **U.S. Supreme Court** in the action *The Little Sisters of the Poor Saints Peter and Paul Home v. Commonwealth of Pennsylvania*, upheld the regulations of the **Trump** administration allowing employers with religious

objections to decline to provide in their health insurance coverage for contraception, abortifacient drugs, and sterilization.

Writing for the Court, **Justice Clarence Thomas** held: "For over 150 years, the Little Sisters have engaged in faithful service and sacrifice, motivated by a religious calling to surrender all for the sake of their brother. ... **But for the past seven years, they - like many other religious objectors who have participated in the litigation and rulemakings leading up to today's decision - have had to fight for the ability to continue in their noble work without violating their sincerely held religious beliefs.**"

In 2011, under **President Barack Obama's Affordable Care Act (Obamacare)**, his administration mandated employers and insurers to provide health insurance coverage of all methods of contraception and some abortifacients, approved by the **Food and Drug Administration**, at no cost to the insured. Failure to comply would result in substantial fines that would overwhelm the finances of any medical provider.

While churches, synagogues, and mosques were exempt from the mandate, other religious organizations such as schools, hospitals, nursing homes, children's homes, and other charities were not.

Although many religious organizations, including many so-called Catholic ones, kept their silence, this bold and courageous women's religious order stood their ground.

Refusing under any circumstances to participate in an intrinsically evil act, the Little Sisters sought relief from the courts, and in 2016 by a unanimous decision of the U.S. Supreme Court, the Little Sisters were relieved of the mandate.



### **President Trump**

After **President Donald Trump** took office in 2017, he directed HHS to write an exemption from such mandates for religious organizations.

"When I asked you for your support in 2016, Americans of faith were under assault. But the shameful attempt to suppress religious believers ended the day I took the oath of office," proclaimed the President this year.

"My administration has taken historic action to protect religious liberty. We're protecting the conscience rights of doctors and nurses and teachers and groups like the Little Sisters of the Poor. We're with them."

However, a number of pro-abortion Democrat state attorneys general filed suits in California and in Pennsylvania seeking injunctions against this new HHS religious exemption.

### *A Temporary Fix*

The decision of the Supreme Court upheld President Trump's exemption. **However, if the pro-abortion Joe Biden (D) is elected president, he will reinstate his and Obama's mandate, and the persecution of religious groups will once again proceed.**

"As disappointing as the Supreme Court's ruling is, there is a clear path to fixing it: electing a new President who will end Donald Trump's ceaseless attempts to gut every aspect of the Affordable Care Act. If I am elected, I will restore the Obama-Biden policy that existed before the Hobby Lobby ruling," threatens Biden.

The pro-abortion Democrat state attorneys general never submitted any affidavits that any woman was in any way deprived of so-called reproductive services, or was harmed in any way by President Trump's exemption, which clearly demonstrated that the primary purpose of the Obamacare mandate was not to provide women with such unnecessary so-called "medical services." **The true purpose of the pro-abortion Democrats is to use the awesome power of the federal government to destroy any religious group that would not participate in the intrinsically evil acts of contraception, sterilization, or abortion.**

May God bless the **BIG** Little Sisters of the Poor.

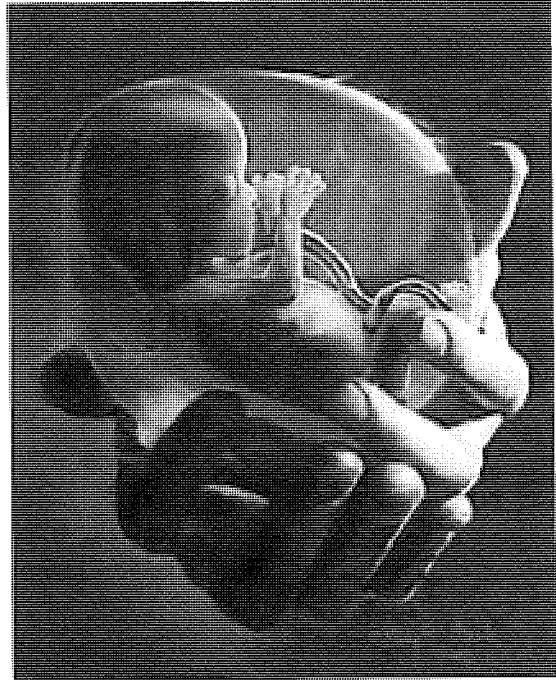
## **PRESIDENT TRUMP PROMOTES ADOPTION AND FOSTER CARE**

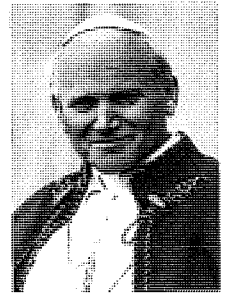

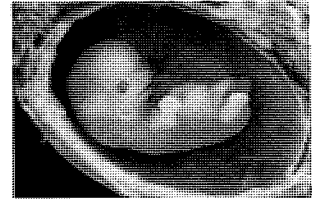


- feeding the poor and welcoming refugees;

## NORTHERN KENTUCKY RIGHT TO LIFE 2020 GENERAL ELECTION CANDIDATE QUESTIONNAIRE

Pursuant to our long-standing policy of bringing to the public the views (and records) of candidates for public office, on these crucial "Life" issues, NKRTL sent questionnaires to candidates seeking office in the general election of November 3, 2020. After furnishing them detailed information concerning the issues, NKRTL advised them that their response (or the fact of their non-response, which could only be interpreted as unfavorable in that they either oppose its positions or are disinterested in these vital issues) would be published.

1. Will you actively support (and if in a position to do so, sponsor and vote for) a mandatory Human Life Amendment to the U.S. Constitution and to the Kentucky Constitution, which would codify the personhood of an unborn child from the moment of fertilization, and which would hold that all innocent human beings have the same right to life, from fertilization until natural death?
2. Will you actively support (and if in a position to do so, sponsor and vote for) legislation which will make it a criminal offense to perform, to assist with, or to pay for an abortion on another (such legislation would not prohibit those necessary medical procedures required to prevent the death of the mother who is suffering from a physical pathology such as ectopic pregnancy or cancerous uterus)?
3. Will you actively support (and if in a position to do so, sponsor and vote for) legislation preventing: (a) the use of tissue and organs from deliberately aborted children; (b) the use or destruction of live embryos for the purpose of extracting stem cells, for transplants or medical experimentations; (c) human cloning, whether for the purpose of development and bringing to full term a new human being, or for the purpose of development of a new human being for experimentation, or for the purpose of obtaining body parts or stem cells; and (d) the public funding of any of these activities?
4. Will you actively oppose (and if in a position to do so, work against and vote against) state or federal legislation or regulation mandating health insurance coverage of abortion (both surgical and chemical) and artificial contraception, and will you actively support (and if in a position to do so, work for and vote for) the repeal of the Affordable Care Act (Obamacare), which provides for the expenditure of funds for the payment of abortion, and for the repeal of the Federal HHS Mandate, a federal regulation enacted under Obamacare, which requires employers, regardless of their religious convictions, to provide healthcare insurance, without additional premium and without a co-payment, for payment of contraceptives, sterilizations, and abortion-producing drugs?
5. Will you actively oppose (and if in a position to do so, work against and vote against) any legislation which would allow the withdrawal from an infant, incompetent, or comatose person of food and water, regardless of how the food or water is provided (except in the case where death is imminent and the patient cannot assimilate food or water)?
6. Will you actively oppose (and if in a position to do so, vote against) any legislation, administrative regulations, or initiatives of any type, which would decriminalize assisting or abetting someone in killing themselves (often referred to as "assisted suicide")?
7. Will you actively support (and if in a position to do so, sponsor and vote for) legislation requiring that the same medical treatment and the same standard of medical care be provided to handicapped persons, and that the decisions of whether to treat a handicapped person must be made on strictly medical grounds and not on speculations about the person's future "quality of life"?
8. Will you actively support (and if in a position to do so, sponsor and vote for) legislation which prohibits all use of local state, federal, and/or Medicare or Medicaid funds for abortion (including chemical abortions, such as RU-486, or the so-called "morning after pill," Norplant, Depo Provera, or the so-called "standard birth control pill")?
9. If there should come before you the question of appointment or confirmation of an individual to any board, agency, or committee, etc., which does or could perform, counsel, refer, or fund abortion (including chemical abortions, such as RU-486, and the so-called "morning after pill," Norplant, Depo Provera, and the so-called "standard birth control pill"), will you nominate or confirm only individuals (1) who refuse to perform, counsel, refer, or fund any surgical or chemical abortion and (2) who refuse to support, vote for, or fund any government or private agency that would perform, counsel, refer, or fund any surgical or chemical abortion?
10. If you become involved in the legislative process, would you take the initiative to compel a recorded vote on all Pro-Life legislation, whether by discharge petition or whatever other parliamentary practice is available?
11. Will you refuse to support in any manner a candidate for any public office, who publicly states acceptance of the current status of legalized abortion, or who fails to disclose his position on the issue of abortion, or who has, as a public official, a record of support for abortion or of failing to oppose it, or who supports any of the above anti-life activities, unless his opponents have done these same things as he has?

## PARTY PLATFORMS

### Republican Party - Pro-Life

The Constitution's guarantee that no one can "be deprived of life, liberty, or property" deliberately echoes the Declaration of Independence's proclamation that "all" are "endowed by their Creator" with the inalienable right to life. Accordingly, we assert the sanctity of human life and affirm that the unborn child has a fundamental right to life which cannot be infringed. We support a human life amendment to the Constitution and legislation to make clear that the Fourteenth Amendment's protection apply to children before birth.

We oppose the use of public funds to perform or promote abortion or to fund organizations, like Planned Parenthood, so long as they provide or refer for elective abortions or sell fetal body parts rather than provide healthcare. We urge all states and Congress to make it a crime to acquire, transfer, or sell fetal tissues from elective abortions for research, and we call on Congress to enact a ban on any sale of fetal body parts. In the meantime, we call on Congress to ban the practice of misleading women on so-called fetal harvesting consent forms, a face revealed by a 2015 investigation. We will not fund or subsidize healthcare that includes abortion coverage.

We support the appointment of judges who respect traditional family values and the sanctity of innocent human life. WE oppose the non-consensual withholding or withdrawal of care or treatment, including food and water, from individuals with disabilities, newborns, the elderly, or the infirm, just as we oppose euthanasia and assisted suicide.

We affirm our moral obligation to assist, rather than penalize, women who face an unplanned pregnancy.

### Democratic Party - Pro-Abortion

We believe unequivocally...that every woman should have access to quality reproductive healthcare services, including safe and legal abortion. ...We will continue to stand up to Republican efforts to defund Planned Parenthood health centers...We will continue to oppose - and seek to overturn - federal and state laws and policies that impede a woman's access to abortion, including by repealing the Hyde Amendment.

### Libertarian Party - Pro-Abortion

Recognizing that abortion is a sensitive issue and that people can hold good-faith views on all sides, we believe that government should be kept out of the matter, leaving the question to each person for their conscientious consideration.

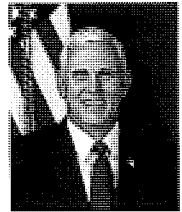

### **Pro-Life Accomplishments of the Administration of President Trump and Vice President Mike Pence**

1. **President Trump is the most pro-life president in history.**  
President Trump became the first president in history to speak at the annual March for Life. Vice President Pence has a long history of being a voice for the voiceless in standing up for the most innocent among us.
2. **Donald Trump and Mike Pence campaigned on the promise to defend life from its earliest stage and to defund Planned Parenthood. President Trump and Vice President Pence have kept that promise.**
3. **April 2017: In the first year of the Trump-Pence administration, President Trump signed a bill that allowed**

states to defund Planned Parenthood of Title X (family planning) funding, reversing an Obama attempt to force states to fund abortion providers.

4. **January 2018:** Reversed an Obama administration policy that blocked states from deciding if Planned Parenthood should be stripped of Medicaid funding.
5. **February 2019:** The Protect Life Rule was finalized, cutting Planned Parenthood's federal funding by \$60 million.
6. **As a result of the President's policies,** Planned Parenthood announced it is withdrawing from the Title X program.
7. **President Trump and Vice President Pence have spent nearly three years actively working to get life-protecting legislation passed.**
8. **The Trump-Pence administration reinstated the Mexico City Policy that ends Federal funding of overseas abortions.**

**Former Vice President and Senator Joe Biden**

"Joe Biden continued his evolution on the issue under Obama. He got there," stated **Kate Michelman**, a former leader of **NARAL**. "I can't say for absolute, 100 percent, but I would trust him as president to protect and defend a woman's right to choose."

From 2001 to 2008, Biden's voting record on pro-life issues was close to zero.

"Biden made his selection [of his vice president running mate] to increase his support among women and people of color, but for people who love America, who love civilization, there can be no support for any candidate in a party that calls for taxpayer-funded abortion throughout pregnancy," states **Fr. Frank Pavone, National Director of Priests for Life**.

"Even with Sen. Harris on the ticket, Americans will have the same choices," Fr. Pavone continued. "Democrat extremism doesn't end with abortion. In this election, voters will choose between a free market or socialism; prosperity or a ruined economy; a secure nation or open borders; the Constitution or judicial tyranny."

"I said when I defeated Robert Bork [to the U.S. Supreme Court], I made sure we guaranteed a woman's right to choose for the better part of a generation. I would make sure that we move and insist that we pass, we codify *Roe v. Wade*," proclaims **Former Vice President and former U.S. Sen. Joe Biden**.

Biden also confirmed that he would force Americans to fund the abortion industry, not only in this country, but throughout the world. "I strongly oppose the limitations on the ability for the United States to contribute to organizations in these countries that, in fact, provide women's health alternatives for choice. ...We should end that limitation. It's called the Mexico City Rule. We should end that," stated Biden.

Biden also promised that if the Supreme Court would overturn *Roe v. Wade*, he would prefer a national law legalizing the killing of unborn children. "If they ruled it [*Roe v. Wade*] to be unconstitutional, I will send to the United States Congress, and it will pass I believe, a bill that legislates *Roe v. Wade*."

**Senator Kamala Harris**

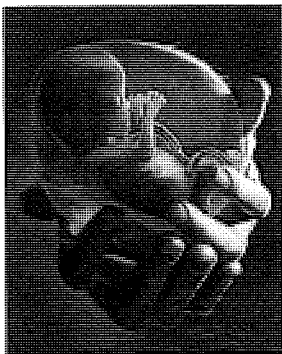
**Sen. Kamala Harris (D)** of California received a 100% rating from **NARAL Pro-Choice America**.

"Kamala Harris is a staunch advocate for women's health and rights. She ran proudly on an agenda to expand access to reproductive healthcare...," stated **former President of Planned Parenthood, Cecile Richards**.

After Biden announced his vice president running mate, **Planned Parenthood Action Fund** tweeted: "Throughout her entire career, @KamalaHarris has been a steadfast champion for reproductive rights..."

"Sen. Harris also co-sponsored the so-called 'Women's Health Protection Act,' known to pro-lifers as the 'Abortion Without Limits Until Birth Act.' As a candidate for president, Harris announced a broad platform that would require states that have a history of passing pro-life laws to seek preclearance from the Justice Department before they could enact any new pro-life laws that would impact abortion on demand. Under her plan, any new pro-life laws would be considered unenforceable without preclearance from the Justice Department," reports *lifeneews.com*.

"With the announcement of Kamala Harris as Joe Biden's running mate, we now have the most pro-abortion ticket in American history," stated **Judie Brown, president of American Life League**. She continued: "Harris is well known for being the first attorney general in California history to bring charges against an undercover journalist for documenting criminal activity. She demonstrated her complete surrender to Planned Parenthood - a self-admitted racist and white supremacist organization - by being at its beck and call."

► "As the presidential primary shifts to New England, it's sad to note that all of the major Democratic candidates are pro-abortion, supporting even partial-birth abortion," states **Bishop Thomas Tobin of Rhode Island**, questioning the Democratic party's allegiance to the abortion industry.

### U.S. SENATE

**Senator Mitch McConnell (R)** has declined to answer our questionnaire, thereby denying the electorate a clear statement of his position on life issues. Sen. McConnell must be recognized for his consistent support for pro-life judicial nominees of **President Trump**, and the skill he has shown in having these nominees confirmed by the Senate. The importance of confirming pro-life nominees to the federal court cannot be emphasized enough. McConnell has a long pro-life voting record, but under his leadership, as Majority Leader, the U.S. Senate continues to fund Planned Parenthood and other abortion providers. Since NKRTL-PAC's policy prohibits it from making any endorsements of any candidate who does not answer the questionnaire or does not give totally pro-life answers, NKRTL-PAC cannot endorse him, but only recommend his reelection.

His opponent, **Amy McGrath (D)**, failed to answer this year's questionnaire, and she also failed to answer our questionnaire two years ago when she was running for the U.S. House of Representatives. "I believe we already have reasonable laws, and I'm very concerned about what's happening in other states like Alabama and Georgia where they're trying to criminalize abortion even in cases of rape and incest and the life of the mother. This is not a government decision. It's a family decision and a very personal decision," she stated in a *Courier Journal*, July 2019 interview/article. "I'm 100% pro-choice. I align with everything Emily's List aligns with." - Amy McGrath, *Bloomberg*, October 31, 2017. (**Emily's List** is a pro-abortion political organization that only endorses candidates who are 100% pro-abortion, and opposed to any type of restrictions on aborting unborn children.)

McGrath put her abortion extremism on full display in a 2018 interview on 590 WVLK, reports *lifenews.com*. "You don't think there should be any limitations at all on abortion?" asked host **Larry Glover**. "I don't think government should be involved in making a decision on a woman's body," McGrath said. "So you think a woman on the way to the hospital to give birth could decide to abort it instead?" Glover said. "I don't think the government should be involved in a woman's right to choose what is happening to her body," McGrath said.

The Libertarian Party candidate, **Brad Barron**, did respond to the questionnaire with all pro-life responses. Since the Libertarian pro-abortion platform supports abortion on demand and opposes any limits or limitations on the killing of unborn children, it is hard to understand how a committed pro-life candidate would decide to run as a Libertarian, which would encourage support for another pro-abortion party.

Based on these considerations, NKRTL-PAC **recommends** both the election of **Senator Mitch McConnell (R)** and **Brad Barron (L)**.

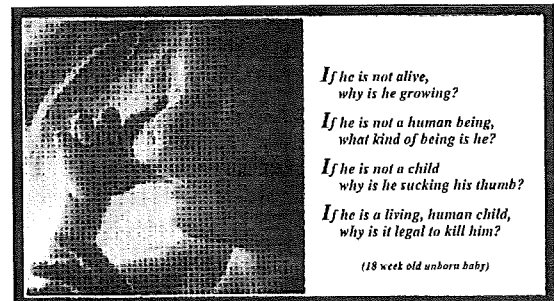

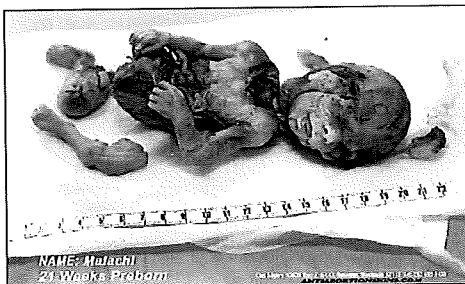

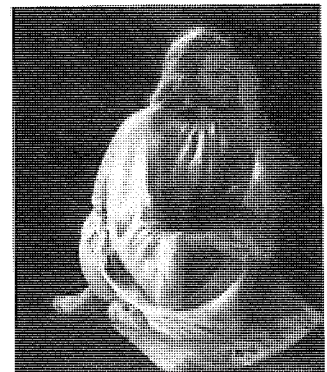
