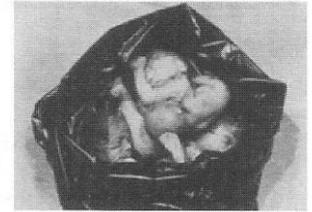




Garbage bag of 18-week unborn infants killed by hysterotomy abortion (Caesarean section)

U.S. Supreme Court Reverses Roe v. Wade

After 50 years of the legalized intentional killing of unborn American children, the **U.S. Supreme Court**, with the three new **Trump**-appointed justices, reversed the most hideous and most unconstitutional decision ever imposed on the American people by the U.S. Supreme Court, i.e., *Roe v. Wade*.

On June 24, the day many Christians celebrate the **Feast of the Sacred Heart of Jesus**, God again revealed His mercy on our country and on our unborn children. Hopefully by God's grace, the United States reached a turning point in the struggle with the culture of death, no longer hampered by the federal judiciary.

God has responded to the prayers and sacrifices of those who love life and who have battled the culture of death:

→Prayer warriors, who have faithfully and continuously prayed in their homes, churches, and in front of the abortion mills.

→Those who stood in front of the abortion mills, not only offering their prayers, but also their assistance in counseling those entering.

→The volunteers who freely dedicated their time and efforts to the problem pregnancy centers, offering women the only true choice.

→Those pro-life residential homes where young mothers are able to receive the education and training they need.

"Roe Must Be Overruled"

In the case of *Dobbs v. Jackson Women's Health Organization*, the Majority Opinion, authored by **Justice Samuel Alito**, and joined by **Justices Thomas, Gorsuch, Kavanaugh, and Barrett**, states:

"Roe was egregiously wrong from the start. Its reasoning was exceptionally weak, and the decision has had damaging consequences...It is time to heed the Constitution and return the issue of abortion to the people's elected representatives.

"The inescapable conclusion is that a right to abortion is not deeply rooted in the Nation's history and traditions. On the contrary, an unbroken tradition of prohibiting abortion on pain of criminal punishment persisted from the earliest days of the common law until 1973.

"We therefore hold that the Constitution does not confer a right to abortion. *Roe* and *Casey* must be overruled, and the authority to regulate abortion must be returned to the people and their elected representatives."

Where Do We Go From Here?

The struggle to stop the intentional killing of unborn children is not over, but will continue in each state. What is God now calling pro-lifers to do? The same thing they have been doing.

We need to continue to reach out to women who are struggling with their pregnancy through our problem pregnancy centers, maternity homes, churches, and charities to assist young mothers in welcoming and celebrating the life of their child.

We need to continue enacting legislation and constitutional amendments which not only ban all abortions, but ensure that pro-life legislation cannot be set aside or ignored at the whims of the executive or judicial branch of government.

The struggle to free our nation of the American holocaust of abortion may have taken a turn, but still demands that we continue to "STAND UP FOR LIFE!" as **St. Pope John Paul II** stated in his visit to the United States.



OUR GUEST SPEAKER, ANGELA MINTER



Angela is the President and Co-Founder of **Sisters For Life**, a Christian 501c3 nonprofit organization. Sisters For Life's mission is to awaken, train, and mobilize the whole church, particularly the historically Black church, to end abortion in the community.

Sisters For Life grew out of Angela's personal experience with abortion. The Lord called her to this great work in 2004 by opening her eyes about the two babies she aborted while a teenager. She speaks with candor about the devastating consequences the abortions had on her spirit, soul, body, and family. Two weeks after her eyes were opened, she began hosting a weekly Christian radio broadcast. She felt a freedom she had never experienced. Angela started to surrender the secret about her abortions publicly and educate the community about the detriment of abortion and its devastating effect on the Black community in particular.

Angela speaks with candor about the devastating consequences the abortions had on her spirit, soul, body, and family.

Angela has appeared on every news channel and the front page of her hometown's leading daily newspaper after holding a press conference and accused **Planned Parenthood (PPH)** of targeting Black people and minorities exposing their genocidal practices. In 2006, the Lord spoke to Angela's heart and revealed that He had not just called her to do a weekly radio program, but He called her to do Sisters For Life full time. Out of obedience to God's assignment, Angela resigned from Commonwealth and

Providian, ending a 20-year career as a licensed sales representative.

God's call opened many doors for Angela. However, the first and most important new door was to do sidewalk counseling at the abortion facility in her state. As a result of her obedience, Sisters For Life rescued over 870 babies, moms, dads, and families from abortion's detriment.

Angela now travels across the country, sharing her story, work, and passion on college campuses, political functions, churches, banquets, galas, and other notable groups. She is also the Founder of **God's Got More Ministries**.

She was appointed a Kentucky Colonel by **Governor Matt Bevin**. She was also selected to be an Honorable Member of Governor Bevin's Post-Secondary Education Nominating Committee. Additionally, Angela has received the educational award from **Kentucky Right to Life**.

Angela is a member of the **National Black Pro-Life Coalition** and the **Frederick Douglass Foundation**. She partners and has been blessed to work with **Dr. Johnny Hunter of LEARN**, **Catherine Davis and her Restoration Project**, **Ryan Bomberger and the Radiance Foundation**, and **Dr. Alveda King of Civil Rights for the Unborn**, among many other honorable organizations.

Angela Minter is an inspired, driven, and compassionate voice for the voiceless and is moved to speak and act by the Word of God, which says in **Proverbs 31:8-9 (New Living Translation – NLT)**:

“⁸Speak up for those who cannot speak for themselves; ensure justice for those being crushed. ⁹Yes, speak up for the poor and helpless, and see that they get justice.”

KENTUCKY IS ABORTION FREE

Kentucky's Ban of Abortion

KRS 311.772 states that when *Roe v. Wade* is reversed, it is a Class D felony (1) to administer a drug with the intent to terminate the life of an unborn human being; or (2) to employ a procedure with the intent to terminate the life of an unborn human being, except to prevent death due to physical conditions or to prevent impairment of a life-sustaining organ. The mother is not subject to any criminal penalty.

Thanks to the Republicans in the Kentucky General Assembly, especially to **State Rep. Joe Fischer (R)** of **Ft. Thomas**, one of the primary sponsors of this 2019 bill, signed into law by **Governor Matt Bevin (R)**, Kentucky is now abortion free.



As reported by the **Associated Press**, the two remaining abortion clinics located in Louisville suspended killing unborn children, canceling about 20 appointments on Friday (June 24).

We need to pray and to encourage expecting Kentucky mothers to reach out to the numerous problem pregnancy centers, churches, and other charities who are anxiously waiting to serve and support them.

REPUBLICANS OVERRIDE BESHEAR VETO OF PRO-LIFE LEGISLATION

“Right to life is not something that is subject to personal opinion. It’s not subject to the medical

profession. It is inherent by our Creator,” stated **Sen. Adrienne Southworth (R)**.

“God granted all of us, born and unborn, the right to life, liberty, and the pursuit of happiness. It is not the right of any person to take this gift away from the weakest among us, who cannot protect themselves no matter the circumstances. I am and will always be an advocate for our children,” professes **Rep. Nancy Tate (R)**.

The **Humanity in Healthcare Act (House Bill 3)** was enacted by a supermajority in both the Republican-controlled **Kentucky House of Representatives** and the **Kentucky State Senate**, only to be vetoed by **Gov. Andy Beshear (D)**, a consistent champion for the abortion industry. The provisions in this bill provided for:

- Bans abortions after 15 weeks.
- Mandates that abortion-inducing drugs can only be provided to a pregnant woman by a qualified licensed physician, and requires abortion pill providers meet the same guidelines as abortion clinic-surgical and medical abortion providers, to see the patient prior to the procedure, establish gestational age, assess appropriate medical history, and post-abortion follow up.
- Requires abortionists to maintain local hospital privileges and be qualified to treat abortion complications.
- Requires that the abortionist, in cases where one parent has consented to the minor undergoing an abortion, make an effort to notify the second parent at least 48 hours before the scheduled abortion.
- Requires that aborted baby remains be cremated or buried, and requires that the mother be informed both orally and in writing of her right to determine the final disposition of the child’s remains. Excludes the child’s remains from the definition of “pathological waste.”
- Prohibits public agency funds from being paid to any entity, organization, or individual that performs or refers for abortion.

How They Voted

As expected, our pro-abortion governor, **Andy Beshear (D)**, vetoed this legislation. However, the veto was overridden in the House by 76 to 21 (3 not voting), and in the Senate by 31 to 6 (1 not voting).

No members from Northern Kentucky voted against overriding the governor.

“I’m bringing this bill to you so that in the event that the Supreme Court upholds the Mississippi legislation as constitutional, we will have a pro-life law in place that would not be subject to a good faith challenge,” states **Sen. Max Wise (R)**.

Most countries limit abortions to 15 weeks or less. The United States, along with Canada, China, and North Korea, have legalized abortion up to the time of birth.

Abortion Pill

Our pro-abortion **President Joe Biden (D)** and his administration began permitting chemical abortion drugs to be sold through the mail without the mother ever seeing a doctor.

The abortion drug mifepristone is used for more than half of all abortions in the United States, according to a new report from the **Guttmacher Institute** (research arm of **Planned Parenthood**). That equates to nearly half a million unborn babies every year, reports *lifeneews.com*.

A first-of-its-kind study in the journal *Health Services and Managerial Epidemiology* found that the rate of emergency room visits related to chemical abortion drugs increased by more than 500% from 2002-2015, as also reported by *lifeneews.com*.

YOU CAN'T BE A FAITHFUL CATHOLIC AND PRO-ABORTION

“After numerous attempts to speak with Speaker Nancy Pelosi (D) to help her understand the grave evil she is perpetrating, the scandal she is causing, and the danger to her own soul she is risking, I have determined that she is not to be admitted to Holy Communion,” concludes **Archbishop Salvatore Cordileone of San Francisco**.



In his May 20 statement announcing that as her bishop he was directing that the **Speaker of the U.S.**

House of Representatives, Nancy Pelosi (D), no longer present herself for Holy Communion.

As he explained in his statement: “Church teaching is clear that people endanger their souls if they are separated from God because of grave sin and then receive the most Holy Eucharist in an unworthy manner. If the Church truly loves them, as she does, then it is more than appropriate to call them back to an intimate relationship with each person of the Trinity through repentance before receiving the body and blood of Jesus in a way that risks their eternal salvation.

“And when that person is a public person, love for the community means guarding against scandal and confusion and allowing others to be led into sin if they don’t see the issue addressed in an appropriate and compassionate manner.”

For 2,000 years, the Catholic Church has taught that an abortion, the intentional killing of an unborn child, is an intrinsically evil act, which can never be morally justified.

For her entire political career, this Democratic U.S. representative from San Francisco could not have been a stronger advocate for legalized abortion, and for federal funding of it. Under her leadership, the Democratic majority in the U.S. House of Representatives passed the radical pro-abortion bill that would, if held constitutional, codify *Roe v. Wade*, permitting abortion up to the time of birth, and striking down any and all pro-life state laws enacted to protect women from the rather lucrative abortion industry. Even some pro-abortion politicians admitted that it would force hospitals and medical providers, regardless of any religious affiliation, to actually participate in the killing of unborn children.

Archbishop Cordileone referred to this legislation as “child sacrifice,” noting that the bill was what “one would expect from a devout satanist,” not a devout Catholic.

Naturally, Speaker Pelosi changes the narrative that the unborn child is the victim, to that she is now the victim. “We just have to be prayerful; we have to be respectful. I come from a largely pro-life Italian American Catholic family, so I respect people’s views about that, but I don’t respect us foisting it onto others,” Pelosi said.

Is not taking the position that it is all right to kill the unborn child foisting that onto the unborn child, destroyed by the painful death of abortion?

Responses by Other Bishops

►“I applaud the courage of Archbishop Cordileone and his leadership in taking this difficult step...for the protection of the unborn, and for the conversion of hearts and minds,” states **Archbishop Paul S. Coakley of Oklahoma City**.

►“I support Archbishop Cordileone in the heroic and compassionate stance he took today in the protection and defense of human life. Every child who, rather than being born, is condemned unjustly to being aborted, bears the face of Jesus Christ,” expressed **Archbishop Michael Barber of Oakland, California**.

►“Representative Nancy Pelosi proudly combines ‘devout’ practice of Catholic faith in her personal life with high-profile promotion of legalized abortion in her political life. The scandalizing gap between belief and behavior on the part of the Speaker of the House grievously misleads her fellow believers about Catholic teaching on social justice and seriously handicaps Catholic efforts to defend unborn life in the womb,” writes **Bishop Liam Cary of Baker, Oregon**. He



continues: “Archbishop Salvatore Cordileone has repeatedly brought these sad facts to Representative Pelosi’s attention and called her to repentance. In response, the Speaker has defiantly doubled down on her uncompromising advocacy for unlimited abortion, thereby proposing herself as an exemplar for Catholic politicians who deliberately distance themselves from the saving clarity of the Gospel of Life. At the same time, in choosing to ally herself actively with abortion’s most extreme proponents, Representative Pelosi has unilaterally broken communion with Archbishop Cordileone and the flock he shepherds. She has withdrawn herself from communion with the Church.”

►“Archbishop Cordileone’s public statement made it clear that this serious measure is ‘purely pastoral, not political’ in a further attempt ‘to help her understand the grave evil she is perpetrating, the scandal she is causing, and the danger to her own soul she is risking...’ This is not a decision that was made rashly, but rather one made after almost ten years of patient dialogue and repeated attempts at reconciliation with the congresswoman and the consistently held teachings of the Catholic Church. Please join me in prayer for Speaker Pelosi, that she may embrace the sacred truth and dignity of the human person, formed in the womb, in the image of God,” teaches **Bishop Donald Hying of Madison, Wisconsin**.


►“All politicians who promote abortion should not receive Holy Communion until they have repented, repaired scandal, and been reconciled to Christ and the Church,” responds **Bishop Thomas Paprocki of Springfield, Illinois**, supporting the decision of Archbishop Cordileone.

Other Bishops Follow Suit

In addition to supporting the decision of the Archbishop, other bishops have also announced that

Speaker Pelosi cannot receive Holy Communion in their dioceses.


►**Bishop Michael Burbidge** announced that Speaker Pelosi may not receive Holy Communion in the **Diocese of Arlington, Virginia**, stating: “He [Archbishop Cordileone] is her bishop, and as that bishop, the direction and guidance he provides is not limited to just a geographical area.”



He continues: “I can’t say it enough, (these) decisions are made for the good of individuals to guard the faithful from scandal, which is caused when Catholics in public office take positions at odds with Church teaching. That confuses people, and a bishop has to guard against that.”

►**Bishop Joseph Strickland of Tyler, Texas**, also announced that “The concern for Mrs. Pelosi’s eternal salvation extends to the Diocese of Tyler. She is barred from Communion here until she repents and stops advocating the murder of children. Pray for her heart to be turned to God and away from the power of this world.”

►The bishop of the diocese where Pelosi has a vacation home also decided to restrict her from receiving Communion. **Bishop Robert Vasa of Santa Rosa** stated: “I have visited with the pastor at [Pelosi’s parish] and informed him that if the Archbishop prohibited someone from receiving Holy Communion, then that restriction followed the person and that the pastor was not free to ignore it.”



Serious pro-lifers throughout our country celebrate the decision of Archbishop Cordileone, and are encouraged by the support of those bishops who stand with him. We continue to pray that other U.S. bishops will accept the grace from God to “stand up for life” and demand that **President Joe Biden** and other pro-abortion elected officials repent or no longer present themselves for receiving the Holy Eucharist.

What About Capital Punishment?

If an elected official is in favor of the application of capital punishment, should he or she also be denied admittance to Holy Communion? The answer is no. The Catholic Church teaches that abortion is intrinsically evil, never justified under any circumstances. On the other hand, whether a government should use capital punishment in regards to serious crimes is a matter about which reasonable Christian minds can differ. **Pope Benedict XVI** made this very clear.



In *Donum Vitae*, which was approved by St. John Paul II and ordered that it be published, **Cardinal Ratzinger (Pope Benedict XVI)** taught: “**Not all moral issues have the**

same moral weight as abortion and euthanasia. For example, if a Catholic were to be at odds with the Holy Father on the application of capital punishment or on the decision to wage war, he would not for that reason be considered unworthy to present himself to receive Holy Communion.

"While the Church exhorts civil authorities to seek peace, not war, and to exercise discretion and mercy in imposing punishment on criminals, it may still be permissible to take up arms to repel an aggressor or to have recourse to capital punishment," Ratzinger continued: **"There may be a legitimate diversity of opinion even among Catholics about waging war and applying the death penalty, but not however with regard to abortion and euthanasia."** (Emphasis by this writer.)

DEPOPULATION, NOT OVERPOPULATION, IS THE CRISIS

Although not an ally to the pro-life movement, this businessman well understands that the global effect of having less children is detrimental to the economic wellbeing of all peoples.

"I think one of the biggest risks to civilization is the low birthrate and the rapidly declining birthrate," states **Elon Musk, Founder of Space X and CEO of Tesla**. "Please look at the numbers. If people don't have more children, civilization is going to crumble."



This famous billionaire told *The Wall Street Journal*: "I can't emphasize this enough, there are not enough people."

In other statements, Musk observed:

"Most people in the world are operating under the false impression that there are too many people. This is not true. Earth could maintain a population many times the current level."

Contradicting other billionaires like **Bill Gates** and **Warren Buffett**, who have been claiming the world is becoming overpopulated, Musk is convinced that depopulation is the real crisis. Gates and Buffett have funded pro-abortion groups across the world.

The effort to debunk the overpopulation myth by pro-life groups the world over is finding more support among secular leaders, especially governments of other countries.

As noted by popular psychology professor and author **Jordan Peterson**: "I've thought for at least ten years that the biggest problem in 50 years will be that there's just not enough people. This idea that the planet has too many people on it...there's no sentiment more implicitly genocidal than that statement."

THE FIRST LIE

"The first lie is that abortion is beneficial to women. That's some CNN fake news right there," remarks **Rep. Lauren Boebert (R-CO)**, speaking to the Democratic-controlled **House of Representatives**. She continues:



"Every abortion results in the death of one person and the injury of another. Abortion is not healthcare, it is murder. I rise to speak in the defense of those who cannot defend themselves. The voiceless, the unborn. I rise to say what we have all known to be true that human life begins at conception because we know science is real," stated Boebert in opposition to the **Women's Health Protection Act** passed by the Democratic-controlled House of Representatives.

With this pro-abortion legislation, the Democrats attempt to codify *Roe v. Wade*, so that also the federal law would create abortion on demand.

In response to this Act, *lifesitenews.com* published the remarks of three women, all of whom had had an abortion and now are strong advocates for the lives of children and women.

"Abortion is not healthcare," states **Kathi A. Aultman, M.D., FACOG, and Associate Scholar with Charlotte Lozier Institute**. "When I worked in the ER, we would treat women who had complications after abortion, but my notes were never reported for statistical analysis because the state didn't require it. You can say anything is safe if you don't keep records," reports Dr. Aultman, a former abortionist.



"That's how Planned Parenthood got started – to control our population. Reproductive justice wants to keep us enslaved. I'm tired of this narrative. We are not victims," states **Halima B. Griffin, MA Public Policy and certified leader of Surrendering the Secret**. "Reproductive justice is a disguise that wants to continue the conversation that Black people are oppressed. Far too many Black people believe we are victims because the system has fed that to us for far too many years. We must start viewing ourselves as victors instead of victims."

In response to the abortion industry's claim that abortion restrictions are misogyny, **Cheryl Kirchbaum**, award-winning author of *ReTested: The Story of a Post-Abortive Woman Called to Change the Conversation*, responds: "I see the complete opposite. I see



abortion as misogynistic. Many post-abortive women – and even women considering abortion – say their baby daddies coerced them into abortion. There’s nothing more misogynistic than suppressing the very thing that only women’s bodies can do.”



From a different perspective, **Jennifer Milbourn**, survivor of a vacuum aspiration abortion, observes: “Abortion denies women their agency – and denies another human a life. Abortion is not healthcare and shouldn’t be considered a women’s ‘right.’ Every life has the right to live. As a survivor of an abortion attempt, I do not support the Women’s Health Protection Act.”

OUR PRO-ABORTION PRESIDENT

To no one’s surprise, and as promised to his pro-abortion donors, **President Joe Biden’s administration**, through the **U.S. Department of Health and Human Services (HHS)**, announced that it would revoke a rule enacted by the **Trump administration** that would provide legal protection to pro-life medical workers from being forced to participate in abortions. If HHS is successful, doctors, nurses, and other healthcare providers would be forced to provide so-called abortion services and other medical procedures that would violate their religious beliefs.

“Doctors, nurses, and other medical providers should enjoy this same constitutional protection, free to live and work in a manner consistent with their faith,” **Alliance Defending Freedom senior counsel Matt Bowman** said in a statement. “Yet the Biden administration’s proposed rule would abandon healthcare professionals to being forced to perform medical procedures that directly violate their religious beliefs or risk losing their jobs.

“This is an illegal and gross overreach of executive power.”

But it does not stop there. Under our pro-abortion president, HHS will be issuing new regulations that require healthcare plans to pay for abortions and procedures for gender-confused individuals.

As reported by *Crux*, these so-called services would include “surgical abortion, cross-sex hormones, gender-transition surgeries, gender-affirming cosmetic surgeries and voice modification – along with a host of expanded services dealing with fertility treatments, contraception, abortifacients, and sterilizations.”

“The forthcoming [HHS] regulation presents an existential threat to Catholic healthcare because the penalties for noncompliance will likely include private enforcement, class-action lawsuits, and ‘qui tam’

actions, which is where an individual can file a lawsuit as if he or she were the United States itself,” warns **attorney Martin Nussbaum, a legal advisor to The Catholic Benefits Association**. “The penalties may also include loss of Medicare and Medicaid funding and even imprisonment for noncomplying healthcare executives.”

In his ongoing efforts to promote “gender-affirming care” as necessary healthcare, the Biden administration issued a document endorsing surgical and chemical mutilation of gender-confused children, claiming, “Providing gender-affirming care is neither child maltreatment nor malpractice. There is no scientifically sound research showing negative impacts from providing gender-affirming care.” This statement not only contradicts numerous experts, and the laws of some states, but also flies in the face of common sense.

“There are no lengths the Biden administration won’t go to in their drive to prop up the abortion industry and impose abortion on demand up to birth nationwide, on a public that resoundingly rejects their agenda,” **President Marjorie Dannenfelser of the Susan B. Anthony List**, reports *lifesitenews.com*.

“GOOD REASON” FOR LEGALIZED ABORTION

“Men like me benefit from safe abortion access,” espouses **Kaivan Shroff**, a senior advisor to the **Institute for Education**, political commentator, alumnus for **Hillary for America’s Digital Team**, and graduate of **Yale University** and **Brown University**.

“**Women’s bodily autonomy should not be up for debate, but men like me have also long been the direct beneficiaries of safe abortion access. Giving women the choice not to carry unwanted pregnancies often means we, too, can delay parenthood until we are ready.**”

A very sad and disturbing statement by a young man, but a very honest acknowledgement as to why many men favor the legalization of a so-called woman's right to kill her unborn child.

"Since I've spent 10 of the past 11 years as a student, most of the women I've had sex with were also students, also progressive, and also not at a point in their lives where they were looking or ready to have children," Shroff says. "I try to share responsibility for birth control, and if a woman tells me she's on it, I also trust that. If she still got pregnant, though entirely her decision, I assume we would both want the same thing: an abortion. In longer-term relationships, we've had explicit discussions about this."

So, if a woman is not responsible in meeting her obligation to make sure she does not become pregnant, then Shroff hopes she will at least be responsible enough to destroy the child growing within, so he can be relieved of any responsibility resulting from the gratification of his sexual drive.

"Admittedly, I've often relied on my female sexual partners to protect me from unwanted pregnancy. During my MBA, I recall panicking in an Uber to the train station after hanging out with a medical student I had met on Tinder and had seen a few times. She had a latex allergy. We didn't use our best judgment. Then I got her text. She had decided to take Plan B [the morning after pill, which is an abortifacient] as an extra precaution. I was relieved," continues Shroff.

"I admit I'm scared of what eliminating access to abortion would mean for my own life."

Do men like Shroff even wonder what abortion means to the life of the unborn child, or to the life of the woman with whom they have conceived a child?

In order for such men not to have to worry or suffer some type of anxiety, it is important for women, to whom they owe no commitment, to be able to have an abortion. Such men having a fear of the responsibility of fatherhood, require the legalization of abortion to assure that they have the peace of mind when pursuing sexual gratification.

So little concern such men have for the woman who may now be pregnant with their child, and for the pain, suffering, and regret that she must experience, so these men can be free to do whatever they want.

For whose benefit do we defend the so-called woman's right to an abortion?

After almost 50 years of legalized abortion, what has sadly become entrenched in our culture is the attitude that a child is simply an object, one which we are free to reject.

Also, abortion on demand has increased the mindset of many men that the woman is only an object from which they desire sexual pleasure, not an individual person they should love, and who also has desires and needs for which they must be willing to make sacrifices.

U.S. TAXPAYERS FUND UN ABORTION EFFORTS

WHAT ARE WE DOING TO OUR CHILDREN?

Championed by the pro-abortion news media, progressive elites of the entertainment industry, and the Democratic Party, the absurd idea that one can change one’s biological sex is doing destructive harm to many children. Only slowly have we seen individuals or groups express horror for what is being inflicted on young men and young women. Most recently, a group of French clinicians published a statement in association with Observatory of Ideological Discourses on Children and Adolescents, excerpts of which are:

It is the phenomenon and its high media profile that concerns us.

“Children are made to believe that a girl could become a boy and vice versa because they have decided to do so without the advice of adults, and this happening at an increasingly young age.

“Trivialized speeches claim that we could do without the biological reality, the sexual difference between men and women, in favour of chosen singularities based solely on ‘feelings.’ These misleading ideological discourses are transmitted on social networks where many teenagers with identity problems come to seek solutions to their malaise. In the name of “self-determination” – a slogan that appeals to all progressives – children and teenagers are convinced that they can change their sex with the help of hormone treatments or even mutilating surgery. This rhetoric, spread by activists in many Western countries, uses fallacies designed to deceive.

“By persuading these children that they have been ‘assigned’ a sex at birth, and that they can freely change it, they are made lifelong patients: lifelong consumers of hormonal chemicals marketed by pharmaceutical companies, recurrent consumers of ever more surgical operations in the pursuit of the chimerical dream of a fantasy body. At present, countries that were in favour of medical transition before the age of majority are banning hormone treatments for minors.

“This dogmatism leads to great confusion so that no one knows how to act and raise their voice, often for fear. But this acronym covers very different people, some of whom, like us, are worried about the current drifts. Some are subject to the law of silence that reigns in this environment.”

The Swedish documentary *Trans Train* shows that young adults, left to their own devices and threatened if they speak out publicly, have been pressured by their community if they have expressed doubts or “detransitioned.”
