# BOY LEFT AT KENTUCKY FIRE HOUSE SAFE HAVEN IS ADOPTED

It was May, 2022, when a newborn baby boy was swiftly taken to the local children's hospital, after having been left at a Louisville, Kentucky, fire station.



Area foster parents, **Chris and Brittany Tyler**, who have fostered 15 children and had two adopted sons, visited little **Samuel**, who weighed three pounds at birth, at the neonatal intensive care unit. "We really wanted to let [Samuel] know that somebody loved him even though they weren't going to be with him for his whole life," stated Chris. "That [his birth mother] loved him and wanted the

best for him, and she trusted that he would go to a good place, and we're thankful to God that he came to us."

Two years later, the Tylers were fortunate to be able to adopt Samuel.



Under the **Kentucky Safe Infants Act**, a mother is able to place her infant in a safe haven, with no questions asked. In response to this statute, **Safe Haven Baby Boxes** have been placed throughout the state of Kentucky, which permit a mother to securely, anonymously, and safely place her infant. The Safe Haven Baby Boxes are equipped to maintain the correct temperature, and a silent alarm notifies authorities that a child has been placed in the box. (See article on pg. 3)

Louisville Fire Department assistant chief Lt. Col. Bobby Cooper said, "If a mom finds herself in a crisis and needs a haven for an infant, this is another resource that's available."

She said these images were horrible," relates Theresa Burke, Ph.D.,

a psychotherapist and founder of Rachel's Vineyard Ministries, and who was the guest speaker at a previous NKRTL Celebration for Life.

"There are people out there like Debbie in tremendous agony and pain because they've suffered the loss of their child or children through abortion, and they

need to talk about it. They need our support and our compassion."


Dr. Burke, in her book,

Forbidden Grief: The Unspoken Pain of Abortion, co-authored with David C. Reardon, Ph.D., Director of the Elliot Institute, exposes grief that women experience, sooner or later, about the abortion they had.

Based on her experience with

counseling

hundreds



clients, she explains how these repressed feelings surface through destructive behavior, failed relationships, eating disorders, alcohol and drug abuse, and other emotional and behavioral problems.

"I felt so terrible for any post-abortive woman, to have her grief dismissed, to have the life of her child trivialized. One of the beautiful things that we do in healing is reconnect with that child and honor the child's dignity and the memory to allow that child's life to bring us meaning because the child does have life in Christ."

#### **HEALING**

"I want to talk about healing," continues Dr. Burke. "We journey through a process of repentance that strips away self-contempt and hatred towards one's self, and replaces it with humility, grief, and tenderness. Repentance is an internal shift in our perceived course of life.

"We begin to develop a spiritual relationship with the aborted children. We name them and put their candles into the living water of Christ, the promise of everlasting life; we will meet them again. They actually meet their child with Christ in a meditation. Their child is whole and safe and happy. They're invited to reflect on the meaning of their child's life.

"They discover the love that God has for them and certainly the love that they have for their child, which they've been denying."

## \*\*January 19, 2024, Ad\*\* "I NEEDED TO BE LOVED"

"What message do I want to bring to American teenagers and their families? didn't need to be lied to. I needed compassion. I needed to be loved. I needed to be getting therapy to help me work through my issues, and not being affirmed in my delusion that by transforming into a boy, I will solve all my problems," stated Chloe Cole, in her testimony before the U.S. House Judiciary

CHILDREN'S INNOCENCE

Subcommittee as to the "dangers of 'gender-affirming care."

At age 18 she had a double mastectomy, and at age 21 "a total hysterectomy, including the removal of my uterus, cervix, fallopian tubes, and both ovaries."

Her testimony continued: "[Gender] transition is a big deal, and we're lying when we say that any of this is reversible. This is a big decision with lifelong consequences."

Gender ideology is simply a lie that a person can selfdetermine, based on their feelings and thoughts, that they

# \*\*January 21, 2024, Ad\*\*

On March 1, 2023, the Falmouth, Kentucky, Police responded to a vacant residence because of a report of an abandoned newborn infant. Upon entry, the officer found a newborn baby unresponsive and not breathing. After being transported to Harrison Memorial Hospital, the newborn baby was declared deceased upon arrival.

#### SAFE HAVEN BABY BOXES

A baby box is a safety device box provided under Safe Haven Laws, enacted by many states, that legally permit a mother in crisis to safely, securely, and anonymously transfer the custody of the newborn child. A baby box is installed in an exterior wall of a designated fire station, hospital, or EMS building. It has an interior door with multiple alarms which allows a medical staff member to secure the newborn from inside the designated building.



Founder, Monica Kelsey, started Safe Haven Baby Boxes, Inc. (https://shbb.org) after learning she was abandoned as an infant. Although the organization's primary goal is to raise awareness of the Safe Haven Laws enacted throughout the country, women in crisis can call the national 24-hour hotline (1-866-99BABY1) and receive counseling and assistance free of charge.

Monica Kelsey states: "We are so grateful to this birth mother for bravely and sacrificially choosing what she believes to be best for her baby. We are honored that she trusted our program to protect her and her infant. There is a real beauty in seeing the families made with these babies, adopted by amazing families. It is a real chance to rewrite tragedy into a blessing."

# WHY DO PRO-LIFERS OPPOSE IVF (IN VITRO FERTILIZATION)?

#### ALABAMA SUPREME COURT

On Feb. 16, 2024, the **Alabama Supreme Court**, in an 8-1 decision, held that human embryos conceived by in vitro fertilization, and who are located outside of a biological uterus at the time they were killed, were children. Thus the **Wrongful Death of a Minor Act** applies to all unborn children, regardless of their location.

In 2020, a client at the IVF clinic removed some embryos, accidentally dropping them, which resulted in the embryonic children's deaths. Three couples subsequently sued the IVF clinic for wrongful death.

The trial court dismissed the case, arguing that frozen embryos are property, not persons. The Supreme Court overruled the trial court, allowing the couples to proceed in pursuing civil damages against the IVF clinic.

"All parties to these cases, like all members of this Court, agree that an unborn child is a genetically unique human being whose life begins at fertilization and ends at death," states the Supreme Court. "...the ordinary meaning of 'child' includes children who have not yet been born."

The Court's ruling relied on Alabama's Constitution, which "acknowledges, declares, and affirms that it is the public policy of this state to ensure the protection of the rights of the unborn child in all manners and measures lawful and appropriate."

#### MADE IN THE IMAGE OF GOD

In his Concurring Opinion, Chief Justice Tom Parker instructs: "...that human life is fundamentally distinct from other forms of life and cannot be taken intentionally without justification – has deep roots that reach back to the creation of man 'in the image of God.' Genesis 1:27"

The Chief Justice quotes
Thomas Aquinas in Summa
Theologica: "As Augustine
observes, man surpasses other
things, not in the fact that God
Himself made man, as though
He did not make other



things...but in this, that man is made to God's image."

Based on this, the Chief Justice concludes: "Human life cannot be wrongfully destroyed without incurring the wrath of a holy God, Who views the destruction of His image as an affront to Himself. Section 36.06 recognizes that this is true of unborn human life no less than it is of all other human life – that even before birth, all human beings bear the image of God, and their lives cannot be destroyed without effacing His glory."

#### "KILLED 30 BABIES TO CREATE ONE"

The outrage by the pro-abortion news media against the Alabama Supreme Court's decision would naturally be expected. How could any court make the outrageous statement that a unique human being's life begins at fertilization? Such a finding undercuts the basic lie of the abortion movement that life does not begin at fertilization.

If pro-lifers really believe that each human life is a gift from God, why would they object to children being conceived by IVF?

In her blog, **Jenny Vaughn** relates a story about IVF procedures done by her and her husband: "The doctor had retrieved 38 good eggs, of which 31 are fertilized. Over the next week, 16 of our embryonic children die and are discarded. Thirteen are cryogenically frozen, mostly two to a vial. Two fresh embryos are transferred to my uterus. ...But at 21 weeks gestation, our twins – Madi and



Isaiah – were born prematurely and only lived for one hour each. ...'It is rare for an embryo to not survive thawing.' Half of our babies didn't survive thawing. ...Of 31 embryos created in a lab, only one survived to be raised by us. ...IVF kills 30 children for every one

that survives."

In the Alabama decision, the Court even noted that the three couples had signed contracts with the IVF center in which "...their embryonic children were, in many respects, treated as nonhuman property: the Fondes [one couple] elected in their contract to automatically 'destroy' any embryos that had remained frozen longer than five years; the LePages [another couple] chose to donate similar embryos to medical researchers whose projects would 'result in the destruction of the embryos'; and the Aysennes [the third couple] agreed to allow any 'abnormal embryos' created through IVF to be experimented on for 'research' purposes and then 'discarded."

Since many embryos fail to implant in the mother's womb, it is a common practice to create more embryos than what will be used. Leftovers are either frozen indefinitely in a cryogenic chamber or simply destroyed.

As the Catechism of the Catholic Church notes: "A child is not something owed to one but is a gift. The 'supreme gift of marriage' is a human person. A child may not be considered a piece of property, an idea to which an alleged 'right to a child' would lead. In this area, only the child possesses genuine rights: the right 'to be the fruit of a specific act of the conjugal love of parents,' and 'the right to be respected as a person from the moment of conception."

No doubt, many couples who desire to have children, which is a good thing, practice IVF, and the children that were conceived are a blessing from God.

But even if couples who conceive a child through IVF may have the best of intentions, the **Catholic Church** has consistently taught that IVF is a grave evil. A good end does not justify evil means.

As explained by Fr. Shenan Boquet, president of Human Life International: "Right now, it is estimated that over one million embryonic human beings are in cryogenic suspended animation in U.S. IVF clinics. Many millions more are preserved in clinics elsewhere on the globe or are being created and experimented upon (and destroyed) in many universities. Tragically, our consciences have been dulled to this industrialized destruction of human life."

## "GENDER-AFFIRMING" TREATMENTS DO MORE HARM THAN GOOD



As reported by Fox News, the American College of Pediatrics (ACPeds) released a position statement in February, in which it stated that "social transition, puberty

blockers, and cross-sex hormones have no demonstrable, long-term benefit on the psychosocial wellbeing of adolescents with gender dysphoria."

"A review of at least 60 research papers demonstrates no benefit to social affirmation, puberty blockers, cross-sex hormones, or surgical interventions for these youth," states **Dr. Jane Anderson,** lead author and vice president of ACPeds.

ACPeds noted that "youth whose perceived gender identity does not align with their biological sex have high rates of mental health problems regardless of any affirmation of their gender identities."

The researchers noted that their study "casts doubt on claims that social affirmation (like using desired pronouns) of transgender-identified youth helps their long-term psychosocial wellbeing."

In their position statement, it was reported: "One study [that] purported to show a 'lifetime suicidal ideation' reduction in those who received puberty blockers actually found twice as many serious suicidal attempts in participants who received the blockers than in those who wished they had received them."

Cross-sex hormonal interventions – treatments that trigger a transition to a desired gender – were also shown to have "little mental health benefit" and were even linked to a higher need for psychiatric care, ACPeds stated.

The doctors concluded that many teens who receive gender-affirming therapy, whether surgical or hormonal, ultimately revert to their biological gender. "There are individuals who now express regret regarding their transition." states Dr. Anderson.

While taking hormone-altering therapies or transitioning to the opposite sex has become "all the rage," states **Dr. Brett Osborn**, a Florida neurologist, the data suggests there is no long-term mental health benefit, reports *Fox News*. "In addition, those opting for hormone-altering therapies are potentially interfering with not only sexual development," Osborn warned. "Testosterone and estrogen, the hormones primarily manipulated with such therapies, are integral to memory formation and mood." He added, "Such ['gender affirming'] surgeries permanently alter one's physical appearance, carrying with them irreversible consequences, such as infertility and sexual dysfunction."

**Dr. Marc Siegel,** clinical professor of medicine at **NYU Langone Medical Center**, and a *Fox News* medical contributor, commented: "Hormone-altering therapies are potentially interfering with not only sexual development, but also brain development. Long-term effects of puberty blockers may include bone loss, trouble concentrating, interference with learning, and interference with fertility."

# ANOTHER SETBACK FOR BIDEN'S EFFORTS TO DISTORT THE LAW

In Jan., 2024, the 5<sup>th</sup> U.S. Circuit Court of Appeals held that the state of Texas can uphold its pro-life laws.

In June, 2022, the Biden administration claimed that the **Emergency Medical Treatment and Active Labor Act** requires that an abortion be performed on a patient with a medical emergency even in states where it has been banned.

In *Texas v. Becerra*, the American Association of Pro-Life Obstetricians & Gynecologists (AAPLOG), the Christian Medical & Dental Association (CMDA), and the state of Texas had filed a suit against U.S. Secretary of Health and Human Services (HHS) Xavier Becerra. Having lost in the district court, the Biden administration appealed. A three-judge panel of the 5<sup>th</sup> U.S. Circuit Court of Appeals rejected the appeal.

"Abortion is not healthcare, and this move by the federal government was specifically designed to force doctors to perform abortions," said CMDA Senior Vice President of Bioethics and Public Policy Jeffrey Barrows, DO, MA (Ethics), who is an OB/Gyn. "Healthcare professionals are focused on trying to save their patients – not on trying to end the lives of the unborn. This grievous attempt by HHS puts our patients at risk, and the appeals court rightly agreed that it is illegal. This decision protects our most fundamental, constitutional freedoms of conscience, speech, and exercise of faith."

"Hospitals - especially emergency rooms - are tasked with preserving life. The 5th Circuit correctly ruled that the federal government has no business transforming them into abortion clinics," said Alliance Defending Freedom Senior Vice President of Strategic Initiatives Ryan Bangert, who argued before the Court, as reported by *lifenews.com*.

Attorney Bangert continued: "Doctors shouldn't be forced to break the Hippocratic Oath, and they shouldn't have to choose between violating their deeply held beliefs or facing stiff financial penalties and being barred from the federally funded health programs. Emergency room physicians can, and do, treat life-threatening conditions such as ectopic pregnancies. But elective abortion is not life-saving care – it ends the life of the unborn child – and the government has no authority to force doctors to perform these dangerous procedures. We are pleased that the courts are allowing emergency rooms to fulfill their primary function – saving lives."

"Induced abortion, the sole purpose of which is to end the life of our preborn patient, is not healthcare, and our members regularly treat serious pregnancy complications without it, which is entirely possible to do under existing Texas law, the AAPLOG stated. "This includes being

able to perform maternalfetal separations when a mother's life is endangered by a pregnancy complication – something that is already allowed by EMTALA as well as by every state law in the country."



# NORTHERN KENTUCKY RIGHT TO LIFE 2024 ELECTION CANDIDATE QUESTIONNAIRE

Pursuant to our long-standing policy of bringing to the public the views (and records) of candidates for public office, on these crucial "Life" issues, NKRTL sent questionnaires to candidates seeking office in the <u>2024 elections</u>. After furnishing them detailed information concerning the issues, NKRTL advised them that their response (or the fact of their non-response, which could only be interpreted as unfavorable in that they either oppose its positions or are disinterested in these vital issues) would be published.



6-week-old unborn child VOTE FOR ME

- 1. Will you actively support (and if in a position to do so, sponsor and vote for) a mandatory Human Life Amendment to the U.S. Constitution and to the Kentucky Constitution, which would codify the personhood of an unborn child from the moment of fertilization, and which would hold that all innocent human beings have the same right to life, from fertilization until natural death?
- 2. Will you actively support (and if in a position to do so, sponsor and vote for) legislation which will make it a criminal offense to perform, to assist with, or to pay for an abortion on another (such legislation would not prohibit those necessary medical procedures required to prevent the death of the mother who is suffering from a physical pathology such as ectopic pregnancy or cancerous uterus)?
- 3. Will you actively support (and if in a position to do so, sponsor and vote for) legislation preventing: (a) the use of tissue and organs from deliberately aborted children; (b) the use or destruction of live embryos for the purpose of extracting stem cells, for transplants or medical experimentations; (c) human cloning, whether for the purpose of development and bringing to full term a new human being, or for the purpose of development of a new human being for experimentation, or for the purpose of obtaining body parts or stem cells; and (d) the public funding of any of these activities?
- 4. Will you actively oppose (and if in a position to do so, work against and vote against) state or federal legislation or regulation mandating health insurance coverage of abortion (both surgical and chemical) and artificial contraception, and will you actively support (and if in a position to do so, work for and vote for) the repeal of the Affordable Care Act (Obamacare), which provides for the expenditure of funds for the payment of abortion, and for the repeal of the Federal HHS Mandate, a federal regulation enacted under Obamacare, which requires employers, regardless of their religious convictions, to provide healthcare insurance, without additional premium and without a co-payment, for payment of contraceptives, sterilizations, and abortion-producing drugs?
- 5. Will you actively oppose (and if in a position to do so, work against and vote against) any legislation which would allow the withdrawal from an infant, incompetent, or comatose person of food and water, regardless of how the food or water is provided (except in the case where death is imminent, and the patient cannot assimilate food or water)?
- 6. Will you actively oppose (and if in a position to do so, vote against) any legislation, administrative regulations, or initiatives of any type, which would decriminalize assisting or abetting someone in killing themselves (often referred to as "assisted suicide")?
- 7. Will you actively support (and if in a position to do so, sponsor and vote for) legislation requiring that the same medical treatment and the same standard of medical care be provided to handicapped persons, and that the decisions of whether to treat a handicapped person must be made on strictly medical grounds and not on speculations about the person's future "quality of life"?
- 8. Will you actively support (and if in a position to do so, sponsor and vote for) legislation which prohibits all use of local, state, federal, and/or Medicare or Medicaid funds for abortion (including chemical abortions, such as RU-486, or the so-called "morning after pill," Norplant, Depo Provera, or the so-called "standard birth control pill")?
- 9. If there should come before you the question of appointment or confirmation of an individual to any board, agency, or committee, etc., which does or could perform, counsel, refer, or fund abortion (including chemical abortions, such as RU-486, and the so-called "morning after pill," Norplant, Depo Provera, and the so-called "standard birth control pill"), will you nominate or confirm only individuals (1) who refuse to perform, counsel, refer, or fund any surgical or chemical abortion and (2) who refuse to support, vote for, or fund any government or private agency that would perform, counsel, refer, or fund any surgical or chemical abortion?
- 10. Will you actively support (and if in a position to do, sponsor and vote for) legislation similar to Kentucky's "Do No Harm Act" (KRS 158.1415; 158.189; 158.191; and 311.372), which provides: (1) that public schools be required to give notification to parents concerning health services related to human sexuality, contraception and family planning, and granting parents the right to withhold consent to said services; (2) that public schools be prohibited from requiring personnel or students to use pronouns that do not conform with the student's biological sex; (3) that students shall not receive instruction in regards to exploring gender identity, gender expression, or sexual orientation; (4) that public schools shall prohibit students from using restrooms, locker rooms, or shower rooms, that are reserved for students of a different biological sex; and (5) that healthcare providers shall not,

for the purpose of attempting to alter the appearance of or to validate a minor's perception of the minor's sex that is inconsistent with the minor's biological sex: (a) Prescribe any drug to delay or stop normal puberty; (b) Prescribe hormones in amounts greater than would normally be produced in a healthy person of the same age and sex; (c) Perform any sterilizing surgery; (d) Perform any surgery that artificially constructs tissue having the appearance of genitalia differing from the minor's sex; and (e) Remove any healthy or non-diseased body part or tissue?

11. Will you refuse to support in any manner a candidate for any public office, who publicly states acceptance of the current status of legalized abortion, or who fails to disclose his position on the issue of abortion, or who has, as a public official, a record of support for abortion or of failing to oppose it, or who supports any of the above anti-life activities, unless his opponents have done these same things as he has?

#### NKRTL-PAC ENDORSEMENTS AND/OR RECOMMENDATIONS

The long-standing policy of NKRTL-PAC regarding candidates for public office is clear and consistent:

- 1. NKRTL sends to each candidate a list of questions comprehensively covering the core sanctity of all innocent human life issues, with a detailed explanatory cover letter, explaining the Pro-Life position regarding each issue and the reasons and authoritative citations for such positions.
- 2. NKRTL explains that it will faithfully publish the candidate's responses, or non-responses, reserving the right to make an endorsement, or recommendation, or take no formal action at all.
- 3. NKRTL advises the candidates that a non-response can only be interpreted as unfavorable in that they either oppose the Pro-Life positions or are disinterested in these vital issues.
- 4. NKRTL publishes as much as it knows about the public record and statements of the candidates on these vital issues.
- 5. NKRTL never endorses a candidate unless his or her answers are 100% Pro-Life.
- 6. NKRTL sometimes makes a **recommendation** of a candidate, after a full disclosure of his positions, if his responses and record are not 100 percent Pro-Life but stand him materially above the other candidates.

Based upon these criteria, NKRTL-PAC publishes its conclusions and comments regarding the candidates in this primary and/or general election in Kentucky.

Northern Kentucky Right to Life Political Action Committee has issued Endorsements and/or Recommendations of some candidates in the upcoming primary and/or general election. These are based not only on the stated public positions of the candidates, including their answers to NKRTL's questionnaire, but also their past public records: Based upon the firm belief that what one has done is entitled to significantly more consideration than what one says ("By their fruits, ye shall know them...." Matthew 7:16), NKRTL undertakes herein to publish what it knows of the public record of these candidates, whether they are incumbents or those seeking office for the first time.

The gravity of the surgical slaughter of 3,800 innocent children each day (one every 24 seconds) – and the even greater number of chemical abortions – demands that we ask of every citizen, particularly those aspiring to public office: "What are you doing to stop the killing?"

If a candidate supported terrorism, would you bother to ask him where he stands on other issues???

NKRTL-PAC does not necessarily make **Endorsements or Recommendations** in every race. NKRTL-PAC never endorses a candidate unless he is 100% Pro-Life, with no exceptions. Sometimes, when NKRTL-PAC considers a candidate superior to the rest of the field, it will make a Recommendation, even though the candidate falls short of its 100% standard for Endorsement.

NKRTL must point out to the reader that some candidates take it upon themselves to modify our questions, thereby failing to answer them specifically, and indeed making exceptions of their own, while simultaneously attempting to answer "yes," to attempt to present a Pro-Life position. Since the candidate has not answered "no," and their response cannot be truly reported as "yes" after they have modified or imposed conditions of their own, NKRTL has appropriately reported those evasive answers with an asterisk (\*). They failed to answer the questions as asked. Such action by the candidate deprives the voter of information on the candidate's position on the issues which the candidate avoided answering.

## **U.S. PRESIDENT**

#### President Joe Biden



President Joe Biden is the most pro-abortion U.S. president. Under his leadership, his administration has used the power of the federal government to remove any and all restrictions and safeguards on abortion, the intentional killing of an unborn child.

Under his administration, the U.S. Food and Drug Administration (FDA) has made the abortion pill an
over-the-counter drug, removing all previous restrictions of the FDA that the pills only be dispensed

in-person to women taking them, and thus allowing these dangerous chemical drugs to be purchased without any sort of medical supervision, without the women knowing what effect it will have on their bodies, or understanding what happens to the child growing within. Biden's **U.S. Department of Justice** also declared that such abortion pills could be mailed across the country.

- Biden has sought to remove the conscience protection from doctors and nurses who refuse to assist in abortion and/or assisted suicide.
- Biden has used the Emergency Medical Treatment and Labor Act to coerce care facilities to commit the killing
  of unborn children on their premises.
- Biden has forced the U.S. Department of Veterans Affairs to provide to veterans and VA beneficiaries what he
  calls "abortion care."
- Biden insists that funds of the **U.S. Department of Defense** be used to pay traveling expenses for those in the military to have an abortion.
- Biden's U.S. Department of Justice supported lawsuits challenging state laws that oppose or place modest limits on abortion.
- Biden's U.S. Department of Justice has arrested and prosecuted those protesting in front of abortion mills.
- Biden has promised work to codify in the federal law *Roe v. Wade*.
- Biden's **U.S. Department of Health and Human Services** revoked the **Trump** administration's ruling which prohibited medical providers from being forced to perform abortions or to perform transgender "treatment."
- Biden's U.S. Department of Health and Human Services also issued a mandate requiring all pharmacists who
  serve those with Medicaid or Medicare to dispense abortion drugs, threatening legal action against any pharmacy
  that fails to do so.

#### **Donald J. Trump**



In the four years **Donald J. Trump** served our nation as president, many pro-life groups acknowledged that he was the most pro-life president.

- Trump promised to appoint to the U.S. Supreme Court, U.S. Courts of Appeals, and U.S. District Courts those who uphold the sanctity of human life.
- With his appointments to the U.S. Supreme Court, the infamous decision of Roe v. Wade was reversed, a decision celebrated by Trump.
- Trump opposed tax funds being used to pay for abortions.
- Trump supported medical care being provided to children surviving an abortion.
- Trump was the first president to speak at the National March for Life in Washington, D.C.
- At the Republican 2019 National Convention, Trump allowed and encouraged a number of pro-life speakers to address the nation.
- Trump enacted pro-life policies, including cutting off Title X funds from Planned Parenthood and other abortion
  providers, and reinstated the Mexico City Policy which forbids taxpayer funds from paying for abortions in other
  nations
- Trump has criticized gender ideology, stating that he would cut off funds to schools that push transgenderism; and has opposed the mutilation of minors by so-called "treatment" by puberty blockers, hormones, and surgery.

However, recently Trump claimed that he could work out a deal between those who favor abortion on demand, with those who uphold the sanctity of all innocent human life, a deal which would "make both sides happy." Mr. Trump perceives that there could be a compromise on abortion by enacting a federal statute outlawing abortions after so many weeks. Although it is unclear, he seems to support a 15-week ban on abortion. There is no compromise that will make everyone happy, since the Democratic party and their supporters in the news media will never abandon their advocacy of abortion on demand, without any limits or restrictions. On the other hand, pro-lifers know that it is morally unacceptable to ever compromise the life of an innocent unborn child.

Thus, a 15-week abortion ban would at best eliminate about 5% of abortions. At eight weeks, a child has all of his organs. At 13 weeks, a child's ovaries or testes are fully developed, and genitals are now forming. At 15 weeks, the baby now hears sounds from the outside world, and their eyes are sensitive to light.

With Biden's strong and aggressive pro-abortion position, and with Trump's prior pro-life record (even though far from 100%), **NKRTL-PAC** recommends the election of <u>Donald J. Trump</u> (R) as president of the United States.

#### **U.S. REPRESENTATIVE - 4TH DISTRICT**

NKRTL-PAC endorses Thomas Massie (R) for reelection to the U.S. House of Representatives. Not only are his answers 100% pro-life to our questionnaire, but he has stood up for those who stand up for life and has supported the passage of much of our pro-life legislation in Washington, D.C., including, but not limited to (see below): Life at Conception Bill; Heartbeat Bill; Pain-Capable Bill (20 week bill); and Conscience Protection Act.

Rep. Massie was the first public figure to defend the students and chaperones from Covington Catholic in spite of the massive onslaught by the pro-abortion news media.

#### **STATE SENATOR - DIST. 11**

Seeking the senate seat held by the pro-life advocate John Schickel (R) (who is retiring this year) are two strong prolife advocates. Both Duane Froelicher (R) and Steve Rawlings (R) responded 100% to the candidate questionnaire. Both have been supporters of NKRTL. However, since Steve Rawlings, who currently serves the Kentucky House of Representatives, has a track record of voting 100% pro-life and has introduced legislation to ensure religious freedom and to protect conscience rights of medical providers, NKRTL-PAC endorses Steve Rawlings (R).

#### **STATE SENATOR - DIST. 17**

NKRTL-PAC endorses the election of <u>Julia Jaddock (R)</u>, based upon her 100% pro-life answers to the questionnaire.

#### **STATE SENATOR - DIST. 23**

Although State Senator Chris McDaniel (R) has a pro-life voting record, and has spoken out against abortion, it is a disappointment that he has declined this year to respond to NKRTL's candidate questionnaire. NKRTL-PAC declines to make any endorsement at this time; hopefully, Senator McDaniel will answer NKRTL's candidate questionnaire with 100% pro-life responses, so NKRTL-PAC can again endorse his candidacy in the November general election.

#### **KENTUCKY HOUSE OF REPRESENTATIVES**

#### STATE REPRESENTATIVE - DIST. 60

NKRTL-PAC endorses the reelection of Marianne Proctor (R), based not only upon her 100% pro-life answers to the candidate questionnaire, but also upon her 100% pro-life voting record and her continual support for NKRTL (including its events), attending the March for Life, and being a member of the Right to Life Caucus.

#### **STATE REPRESENTATIVE - DIST. 61**

NKRTL-PAC endorses the reelection of Savannah Maddox (R), based not only upon her 100% pro-life answers to the candidate questionnaire, but more notably her 100% pro-life voting record, her continual support for NKRTL (having spoken at a couple of our events), and her willingness to speak about life issues to various groups, expressing her commitment to the pro-life movement, especially in regards to her support of problem pregnancy centers.

#### **STATE REPRESENTATIVE - DIST. 63**

Based upon her failure to respond to NKRTL's candidate questionnaire, and based on her vote not to override Gov. Andy Beshear's (D) veto of the Do No Harm Act, which passed in the 2023 Kentucky General Assembly, NKRTL-PAC does not endorse Rep. Kim Banta (R).

For a summary of Kentucky's "Do No Harm Act," see Question #10 of NKRTL's 2024 candidate guestionnaire, listed on page 6 of this newsletter. This bill has been referred to in the pro-abortion news media as "the anti-transgender care" act. It was not surprising that pro-abortion Gov. Beshear vetoed the legislation, which was overwhelmingly enacted in both the House and in the Senate, and then his veto was overwhelmingly overridden by the House and the Senate. However, it was a great disappointment that three of the "no" votes against the legislation and against overriding the governor's veto

were by three Northern Kentucky state representatives: **Kim Banta (R)**, **Kimberly Poore Moser (R)**, and **Stephanie Ann Dietz (R)**. All of the Northern Kentucky state senators voted "yes" for the legislation and "yes" to override the governor's veto.

#### The State Has a Compelling Interest

A letter released December, 2017, initiated by the U.S. Conference of Catholic Bishops, and joined by faith leaders from the Lutherans, Anglicans, Orthodox, Presbyterians, and Southern Baptists, addressed the great harm we are doing to our children by promoting what today is called "transgenderism."

"We come together to join our voices on a more fundamental precept of our shared existence, namely, that human beings are male or female and that the socio-cultural reality of gender cannot be separated from one's sex as male or female," the letter begins.

"Children especially are harmed when they are told that they can 'change' their sex or, further, be given hormones that will affect their development and possibly render them infertile as adults. Parents deserve better guidance on these important decisions, and we urge our medical institutions to honor the basic medical principle

of 'first, do no harm.' Gender ideology harms individuals and societies by sowing confusion and self-doubt.

"The state itself has a compelling interest, therefore, in maintaining policies that uphold the scientific fact of human biology and supporting the social institutions and norms that surround it," as stated in the above letter.

The letter continues: "The movement today to enforce the false idea - that a man can be or become a woman or vice versa - is deeply troubling. It compels people to either go against reason - that is, to agree with something that is not true or face ridicule, marginalization, and other forms of retaliation."

#### **STATE REPRESENTATIVE - DIST. 64**

**NKRTL-PAC endorses** <u>Karen Campbell (R)</u>, based not only upon her 100% pro-life answers to the candidate questionnaire, but also upon her active support for NKRTL (including attendance at our Celebration for Life), and her attendance at the rallies at the state capitol.

Although NKRTL-PAC had in prior elections endorsed the incumbent, **Rep. Kimberly Poore Moser (R)**, it declines to do so now, based partly on her responses to the 2024 candidate questionnaire not being all pro-life, and because of her voting "no" on the **Do No Harm Act** and voting "no" to override Gov. Beshear's veto.

#### **STATE REPRESENTATIVE - DIST. 65**

Although NKRTL-PAC had endorsed in 2022 the election of the incumbent **Rep. Stephanie A. Dietz (R)**, it this year makes no endorsement in this race because of her declining to respond to the 2024 NKRTL candidate questionnaire, and because of her voting "no" on the **Do No Harm Act** and voting "no" to override Gov. Beshear's veto.

#### **STATE REPRESENTATIVE - DIST. 66**

**NKRTL-PAC endorses the election of** T. J. Roberts (R), based upon his 100% pro-life answers to the candidate questionnaire, and his longtime support of NKRTL (including attendance at its events) and his membership and activity with **Students for Life**.

#### **STATE REPRESENTATIVE - DIST. 67**

**NKRTL-PAC** declines to make an endorsement in this race, since the two Republicans failed to answer the NKRTL candidate questionnaire, and the Democratic candidate's responses were not 100% pro-life.

#### **STATE REPRESENTATIVE - DIST. 68**

Although State Rep. **Mike Clines (R)** has a pro-life voting record, and has spoken out against abortion, it is a disappointment that he has declined this year to respond to NKRTL's candidate questionnaire. NKRTL-PAC declines to make any endorsement at this time; hopefully, State Rep. Clines will answer NKRTL's candidate questionnaire with 100% pro-life responses, so NKRTL-PAC can again endorse his candidacy in the November general election.

#### **STATE REPRESENTATIVE - DIST. 69**

**NKRTL-PAC endorses the reelection of the incumbent, State Rep.** <u>Steven Doan (R)</u>, based upon his 100% prolife answers to the candidate questionnaire, his active support of NKRTL (including attendance at its events), his attendance at state rallies, and his 100% pro-life voting record as a state legislator.

#### **STATE REPRESENTATIVE - DIST. 78**

**NKRTL-PAC** endorses the reelection of the incumbent, State Rep. Mark Hart (R), based not only upon his 100% pro-life answers to the candidate questionnaire, his 100% pro-life voting record in the Kentucky House of Representatives, and his continual support for NKRTL (including attendance at its events), his attendance at state rallies, and his unfailing support for pro-life legislation.
